Core purpose			
<ul style="list-style-type: none"> ● Use teaching and learning objectives to plan, evaluate and adjust specified learning activities to an individual ● To support the teacher with their responsibility for the development and exceptional education of a child with special educational needs. ● Using routine supervision and care skills to support the child 			
Key accountabilities			
<ul style="list-style-type: none"> ● To assist in the delivery of educational work programmes for the specific child by participating in day to day learning activities, supporting the child so that they achieve to the best of their abilities. ● Work with the child on therapy or other individualised programmes, designed and supervised by a therapist/care professional. ● Provide specialist support to pupils with significant learning, behavioural, communication, social, sensory, or physical difficulties. ● Monitor the child's conduct and behaviour throughout the learning process and intervene to resolve highly complex, difficult, or very challenging issues. ● Develop and implement individual development plans for the child (such as individual educational plans), which may include attendance at, and contribution to, reviews. ● To support in planning and evaluating programmes and adapting teaching materials to suit the particular requirements of the individual child. ● To discuss with and report back to the teacher on the assessment of the child's work and support with any additional paperwork such as ISP writing, end of term level judgements etc. ● To contribute to the carrying out of programmes, including literacy and numeracy, keyboard skills, life skills and to ensure that the programme is delivered professionally at all times. ● To deliver intervention programmes to the specific child to accelerate progress. ● To participate in staff development activities and, where required to contribute to any multi-disciplinary discussion of a child's needs/progress. ● To work as part of a team to ensure that the well-being, behaviour and personal development of the specific child enhances their learning opportunities and like skills. Liaising with the SENCO informing of progress and concerns. ● To liaise and feedback to the parents of the specific child in a professional manner, in combination with the class teacher. ● To maintain confidentiality in and outside the workplace. ● To understand and assist in interpreting school policies. 			

Other

- Any other duties commensurate with the role as directed by the Headteacher.
