



## **JOB DESCRIPTION**

Job Title: Assistant Site Manager

**Grade:** B1 SCP 4 - 6 Reporting to: Site Manager

#### Job Purpose:

Under the direction instruction of the Site Manager and / or appropriate senior staff, provide of maintenance and security services on the Leeds Mathematics School (LMaS) site as directed by the Site Manager, thereby ensuring a safe and efficient working environment for all staff, students and visitors.

# **Duties include:**

## Security

- Lock / unlock the LMaS site and areas within (as required).
- Assist with regular security checks.
- Operate alarm systems where appropriate.
- Cover evening events and lettings (as required).

## **Cleaning and Maintenance**

- Assist with minor / simple repairs e.g. minor plumbing, changing light bulbs, unblocking drains, repairing door furniture.
- Collect and assemble waste for collection.
- Undertake cleaning duties including litter-picking.
- Undertake emergency cleaning duties.
- Provide emergency access to the school site.
- Undertake activities to maintain a safe and clean external environment.

#### Resources

- Ensure the maintenance of a clean and orderly working environment.
- Timely and accurate preparation of routine equipment / resources / materials as set out in instructions.
- Undertake basic record keeping as directed.
- Refill and replace consumables e.g. soap and towels (as required).
- Report faulty equipment and other maintenance requirements to the appropriate person.
- Maintain the security of the LMaS site by securing entrances / exits as appropriate and reporting potential security breaches.
- Ensure lights and other equipment are switched off as appropriate.
- To work alongside other colleagues to determine the smooth running of Open / Parents' Evenings.

# **Organisation**

- Assist with the receipt, distribution, collection and despatch of goods.
- Assist and participate in the organisation and movement of furniture within the building.
- Maintain and arrange orderly and secure storage of supplies.
- Operate everyday equipment in accordance with instructions.

# **Responsibilities:**

Deputise for the Site Manager in his absence to ensure the smooth running of the site.
