#### **JOB DESCRIPTION**

##### **JOB PURPOSE:**

To contribute to the development of a strong, effective school with an emphasis on promoting a culture of educational excellence, within a caring and secure Islamic environment enriched with the values of discipline, mutual care and respect which extends beyond the school into the wider community.

##### **JOB SUMMARY:**

1. Be an advocate for developing and implementing school ethos to ensure that all students within the school have an exceptional learning experience.
2. Be responsible for ensuring that all students have high aspirations to realise their potential.
3. Support and assist the Principal by providing dynamic instructional leadership and management by sharing and modelling the school's vision and values in everyday work and practice.
4. Develop, coach and motivate staff, setting high expectations, embedding learning and teaching strategies and raising achievement.
5. Contribute to rigorous and on-going evaluation.
6. Take responsibility for leading specific areas/initiatives to secure further school wide improvements.
7. Devise and implement a development plan for the Departmental staff with clear annual targets using up to date performance data.
8. Develop, demonstrate and disseminate across school a range of strategies for outstanding learning and teaching to raise the achievement of the subject, and of different students.
9. Sustain and enhance attainment in designated subjects within the Department by embedding innovative assessment for learning tools.
10. Develop and manage the introduction of new and revised curricula.
11. Assist in the development of teaching staff, providing support where necessary.
12. Plan, support and deliver intervention and enrichment programmes outside of school hours to support learning and achievement by all students.
13. Demonstrate commitment to professional development of self and others by undertaking and leading professional learning provision.
14. Liaise with a range of educational partners within school and beyond to support the progress and attainment of students within the Department.
15. Actively engage with parents to ensure students' learning extends to their home life.

## **KEY RESPONSIBILITIES AND ACCOUNTABILITIES**

### **1. Overall Strategic Direction and Development**

- 1.1. Provide inspiring and purposeful leadership for the students within a caring and secure Islamic environment.
- 1.2. Work in partnership with the Principal, Senior Leadership Team, Local Governing Body, Star Central, staff, students and parents in generating the ethos and values which underpin the school enriched by mutual care and respect extending into the local community.
- 1.3. Work within the overall aims and objectives of the school.
- 1.4. Promote and deliver the priorities and policies of the school by contributing to School Improvement and Development Planning, by consistently and persistently implementing agreed policies and initiatives and adhering to the school's ethos within and beyond the school.
- 1.5. Liaise as required with a range of educational partners, internal and external, to underpin the raising of student attainment.
- 1.6. Support the school's home and community liaison work through the appropriate participation in events.
- 1.1. Contribute to and/or develop and deliver strategies for effective communication, including weekly staff and student briefings, and regular team and management meetings.
- 1.7. Support the development of the timetable. Including responsibilities around co-construction and backup.

### **2. Teaching and Learning**

- 2.1. Create and maintain an ethos of excellence and endeavour that promotes and secures outstanding teaching, excellent learning and the highest standards of achievement.
- 2.2. Support and implement the curriculum and its assessment.
- 2.3. Ensure that standards in literacy, numeracy and the subjects within the English Baccalaureate are priority targets for all students, including those with special educational needs.
- 2.4. Support and implement the policy for the personal, spiritual, social, moral and cultural development of students.
- 2.5. Create and sustain an effective partnership with parents to support and improve students' achievement and personal development.

### **3. Curriculum and Assessment**

- 3.1. Lead on the implementation, promotion, dissemination, and monitoring of whole-school strategies.
- 3.2. Work closely with the Assistant Principal to develop and manage overall curriculum of the school.
- 3.3. Lead on KS3 examinations and assessments.
- 3.4. Lead on KS3 pupil grouping and setting.
- 3.5. Liaise with the Assistant Principal and Data & Exams Manager to lead on examinations, and data & reporting for KS3.

### **4. Intervention**

- 4.1. Lead on KS3 academic intervention management.
- 4.2. Lead on KS3 academic performance reviews.
- 4.3. Support with whole school and faculty CPD to improve the quality of curriculum content.

- 4.4 Be involved in the coaching and mentoring of staff at different stages of their career in the faculty and across the school.
- 4.5 Collaborate as part of the extended Senior Leadership Team, in the implementation and delivery of the whole school improvement plan.
- 4.6 Establish good relationships, encourage and celebrate good working practices, supporting and leading teachers.
- 4.7 Support and maintain the aims, ethos and core values of the school and their practical expression through agreed policies.
- 4.8 Devise and lead on a programme of 'catch up' for Key Stage 3 to give students the best possible opportunity of catching up quickly and not falling behind their peers.
- 4.9 Ensure all new KS3 students complete a CAT test and a Reading Age test.
- 4.10 Ensure comprehensive analysis of external KS2 data in relation to internal CATs and Reading Age data.
- 4.11 Support the option process at the end of KS3.

## **5. Communication**

- 5.1 Support on KS3 academic reporting.
- 5.2 Support on KS3 parental report cards.
- 5.3 Lead on KS3 parent evening organisation.
- 5.4 Liaise with all curriculum areas in relation to KS3 delivery and initiatives.
- 5.5 Support and lead faculties to enhance assessment for learning and intervention at KS3.
- 5.6 Develop and lead implementation of strategies to secure high levels of learner achievement in each subject within KS3.
- 5.7 Support the development and implementation of strategies to secure outstanding teaching within all faculties.
- 5.8 Support the development and implantation of strategies to secure excellent behaviour and safety within the school.
- 5.9 Support the development and implementation of strategies to secure excellent leadership and management of staff across the school.

## **6. Leadership of a Year Group**

For a designated year group:

- 6.1 Provide ongoing academic and pastoral support to the Head of Year.
- 6.2 Undertake 'Performance Review' meetings with parents of learners at risk of failing to achieve in GCSE English and Maths.
- 6.3 Develop and lead the implementation of strategies to support academic achievement and personal development to all learners.

## **7. Leadership of English**

- 7.1 Line manage staff and other TLR holders within the department and hold overall responsibility for the performance of all staff within the department.
- 7.2 Lead the development of the KS3, KS4 and KS5 curriculum across the department of responsibility.
- 7.3 Uphold Trust Quality Standards across the department.

- 7.4 Ensure that all subjects within the department deliver outstanding levels of achievement and attainment.
- 7.5 Lead, train, coach and develop colleagues in the department.
- 7.6 Assist colleagues in the planning and delivery of the schemes of work and provide guidance on the choice of appropriate teaching and learning methods to meet the needs of the subject, and of different students.
- 7.7 Guide and support colleagues in the management of students in the classroom in line with the school's Behaviour Policy.
- 7.8 Recognise and utilise the strengths of each member of the department by differentiating and delegating tasks appropriately.
- 7.9 Hold departmental meetings and keep records of matters discussed and decisions taken.
- 7.10 Ensure that work is provided for classes of absent colleagues and that cover is arranged in accordance with the school's agreed procedures.
- 7.11 Liaise with the Principal on present and future departmental staffing matters including recruitment, induction, current responsibilities, professional review and development.
- 7.12 Support the school's programmes for New Staff induction, NQT Induction and Initial Teacher Training.
- 7.13 Take a lead role in the professional review of colleagues in the department.

## **8. Management of Students**

- 8.1 Organise students into teaching groups.
- 8.2 Provide schemes of work that ensure continuity and progression in the subject for all students, including those of high ability and those with learning support needs.
- 8.3 Identify, after consultation with colleagues, able and talented students and those with learning support needs and arrange appropriate action and intervention.
- 8.4 Devise a departmental policy for rewarding achievement in line with the school's Rewards Policy.
- 8.5 Promote Personalised Learning by encouraging the use of teaching and learning strategies which develop the competence and confidence of every student.
- 8.6 Organise the setting and marking of school examinations and supervise entries for public examinations.
- 8.7 Provide careers advice relevant to the department.
- 8.8 Initiate and foster extra-curricular activities which widen students' appreciation of the subject and contribute to the general life of the school.

## **9. Management of Resources**

- 9.1 Estimate and manage the departmental budget.
- 9.2 Assess needs and priorities in accommodation, advising the Principal on the optimum use of existing rooms as well as future requirements.
- 9.3 Plan and administer the development and storage of equipment, books and other resources.
- 9.4 Advise on security needs of the department and keep a record of stock and equipment.
- 9.5 Supervise the departmental area, fabric, facilities and resources.
- 9.6 Assess all areas of departmental responsibility from a Health and Safety viewpoint in liaison with the Business Manager.
- 9.7 Ensure that departmental rooms present stimulating environments which help to influence students' attitudes positively towards the subject.

## **10. Planning and Development**

- 10.1 Plan and co-ordinate the work of the staff in the Department and disseminate information efficiently.
- 10.2 Plan, implement and review syllabuses, teaching schemes, assessment policies and reporting procedures in accordance with school aims, policies and practices.
- 10.3 Set expectations and targets for staff and students in relation to standards of student achievement and the quality of teaching.
- 10.4 Keep abreast of current developments in the subject area and adapt curriculum content and methods of teaching and examining as appropriate.
- 10.5 Consider such developments in the context of the school's philosophy for the curriculum as a whole.

## **11. Monitoring and Evaluation**

- 11.1 Analyse and interpret relevant national and school data to inform policies, practices and teaching methods.
- 11.2 Monitor teaching standards in the department and use this analysis to identify both effective practice and areas for improvement.
- 11.3 Ensure students' work is regularly assessed and that homework is in line with school policy.
- 11.4 Use information gained from assessment, recording and reporting procedures to generate further improvement in student achievement.

## **12. Communication and Liaison with Other Colleagues**

- 12.1 Support the work of colleagues within the senior leadership team, through the strategic leadership of key processes within school.
- 12.2 Represent the subject, the department or the school in appropriate meetings.
- 12.3 Ensure the line manager and Principal is informed on all issues concerning the department.
- 12.4 Liaise with the business support team in all matters concerning administration, health and safety and external agencies.
- 12.5 Liaise with the pastoral team in respect of student records, rewards and sanctions.
- 12.6 Liaise with the examinations team in issues relating to external examinations.
- 12.7 Maintain effective relationships with other middle and senior leaders in the school.
- 12.8 Maintain appropriate links with teaching colleagues in all sections of Star Schools.
- 12.9 Liaise with other schools, post 18 education providers and local employers where appropriate.
- 12.10 Maintain appropriate links with feeder schools.

## **13. Communication with Parents and the Wider Community**

- 13.1 Contribute to the wider life of the school and its community through out of hours and partnership work.
- 13.2 Establish a partnership with parents to involve them in their child's learning of the subject.
- 13.3 Provide information for parents about curriculum, attainment and progress.
- 13.4 Ensure that the department is represented at Consultation Evenings.
- 13.5 Oversee the departmental input to Personal Records for students.
- 13.6 Assist the pastoral support teams in preparing extra information for parents, when requested, on the attainment, progress and effort of individual students.

13.7 Develop effective links with the wider community, including business and industry, in order to extend the subject and enhance teaching and learning.

#### **14. Other Responsibilities**

14.1 Promote the Trust's vision of 'nurturing today's young people, inspiring tomorrow's leaders'.

14.2 Champion the Trust's values of 'Service', 'Teamwork', 'Ambition' and 'Respect'.

14.3 Contribute to the wider life of the Trust and the Star community.

14.4 Carry out any such duties as may be reasonably required by the Trust.

#### **15. Records Management**

15.1 All staff who create, receive, and use records in the course of their job are responsible for ensuring that records are managed appropriately.
