#### **JOB DESCRIPTION**

##### **JOB PURPOSE:**

To promote a culture of educational excellence, rooted in God's Word, enriched by the values of discipline, mutual care and respect which extends beyond the school into the wider community.

##### **JOB SUMMARY:**

1. Provide support to the Finance Business Partner and Business Manager with regards to the resource and business functions of the school.
2. Contribute to the development and maintenance of financial systems and processes.
3. Provide financial support and administration to the school.

##### **KEY RESPONSIBILITIES AND ACCOUNTABILITIES**

###### **1. Financial Administration**

- 1.1 Assist with the operation and maintenance of the school's manual and computerised financial control and information systems, updating financial records and assisting in the production of financial information and reports for the Finance Business Partner.
- 1.2 Undertake analysis of financial information using computer spreadsheets, if appropriate, as required by the Finance Business Partner.
- 1.3 Support the processing of the financial transactions within the financial systems of the School.
- 1.4 Undertake accounting operations including the receiving and processing of orders, checking and processing invoices and requests for payment, and raising BACS payments for suppliers.
- 1.5 Respond to account queries from staff and suppliers, resolving problems and using discretion in referring issues to the Finance Business Partner.
- 1.6 Support the receipt and bank processing of monies received and following up debts.
- 1.7 Assist the Finance Business Partner with financial month and year end processes.

###### **2. School Administration**

- 2.1 Provide administrative support to the organisation and arrangement of trips and school events.
- 2.2 Maintain manual and computerised records using Management Information Systems if required.
- 2.3 Undertake and follow specified administrative procedures and processes in a professional manner.
- 2.4 Participate in training and professional development opportunities as required to fulfil the role.

- 2.5 Respond to staff, student, parent and other stakeholder queries in a timely and professional manner.
- 2.6 Provide cover for other administration staff during absences.
- 2.7 Support Reception and Reprographics with administrative duties.
- 2.8 Assist with first aid.

### **3. Other Responsibilities**

- 3.1 Work within the Trusts policies and procedures.
- 3.2 Make the best use of ICT equipment and processes.
- 3.3 Contribute to the provision of an effective work environment.
- 3.4 Be aware of, and respect, the confidential nature of issues within the role.
- 3.5 Carry out any such duties as may be reasonably required by the Finance Business Partner/Business Managers.
- 3.6 Attend meetings and training as required.
- 3.7 Provide cover for other administration staff tasks during absences.
- 3.8 Promote the Trust's vision of 'nurturing today's young people, inspiring tomorrow's leaders'.
- 3.9 Champion the Trust's values of 'Service', 'Teamwork', 'Ambition' and 'Respect'.
- 3.10 Contribute to the wider life of the Trust and the Star community.
- 3.11 Carry out any such duties as may be reasonably required by the Trust.

### **4. Records Management**

- 4.1 All staff who create, receive, and use records in the course of their job are responsible for ensuring that records are managed appropriately. It is therefore likely that this post-holder will have responsibility for record-keeping as part of the role. Employees are required to be conversant with the Trust's policies and procedures on records management.
