# **BUSINESS SUPPORT OFFICER – RECEPTIONIST AND PUPIL WELFARE**

## JOB DESCRIPTION

## JOB PURPOSE:

To contribute to the development of a strong, effective school with an emphasis on promoting a culture of educational excellence, within a caring and secure Islamic environment enriched with the values of discipline, mutual care and respect which extends beyond the academy into the wider community.

#### **JOB SUMMARY:**

- 1. Provide a receptionist service for the school.
- 2. Provide effective administrative and clerical support to the school that assists the school in its primary function of teaching and learning.
- 3. Provide administrative and clerical support to the resource and business functions of the school and its estate.
- 4. Provide administrative and clerical support for all aspects of business services, including Finance and Pupil Welfare.
- 5. Be responsible for the exemplary maintenance of pupil records.
- 6. Support links with the community, families and local environment.

## **KEY RESPONSIBILITIES AND ACCOUNTABILITIES**

## 1. Pupil Welfare Administration

- 1.1 Support the effective monitoring of attendance through inputting of daily absence data, preparation of weekly reports for staff and liaising with parents to query and authorise absences.
- 1.2 Undertake training on, utilise and maintain Bromcom Attendance and Behaviour modules effectively.
- 1.3 Undertake the administration of admission applications and admission appeals including recording data and liaising with other schools.
- 1.4 Process the administration of free school lunches for pupils.
- 1.5 Administer first aid to pupils and support the welfare of pupils who are ill or require medical attention.
- 1.6 Provide administrative support in organising safety procedures, including fire drills.
- 1.7 Assist staff in contacting parents and pupils where necessary and liaising with staff on outcomes.

## 2. School Administration

- 2.1 Provide administrative support to the organisation and arrangement of trips and school events.
- 2.2 Provide a responsive and effective reprographics service for the school.

- 2.3 Undertake minuting of meetings as required by the school.
- 2.4 Sort and distribute mail and correspondence to and from staff in a timely manner.
- 2.5 Utilise administrative equipment such as the franking machine, photocopier and laminator as required.
- 2.6 Maintain manual and computerised records using Management Information Systems if required.
- 2.7 Undertake and follow specified administrative procedures and processes in a professional manner.
- 2.8 Participate in training and professional development opportunities as required to fulfil the role.

# 3. Facilities and Estate Management

- 3.1 Be aware of and comply with policies and procedures relating to health and safety, security and reporting all concerns in accordance with school procedures.
- 3.2 Support the safe environment for the stakeholders of the school to provide a secure environment consistent with the ethos of the school and its safeguarding commitments.
- 3.3 Support the administration of Health and Safety issues associated with the premises, ensuring compliance with relevant legislation and Trust requirements.

# 4. Relationships and Communication

- 4.1 Deal with the telephone and personal enquiries from staff, parents and members of the public, ensuring accurate messages are clearly relayed to recipients.
- 4.2 Sign in visitors and contractors, ensuring that the safeguarding procedures are maintained in line with school policy.
- 4.3 Take delivery of parcels.
- 4.4 Respond to staff, pupil, parent and other stakeholder queries in a timely and professional manner.

## 5. Other Responsibilities

- 5.1 Promote the Trust's vision of 'nurturing today's young people, inspiring tomorrow's leaders.
- 5.2 Champion the Trust's values of 'Service', 'Teamwork', 'Ambition' and 'Respect'.
- 5.3 Contribute to the wider life of the Trust and the Star community.
- 5.4 Carry out any such duties as may be reasonably required by the Trust.

## 6. Records Management

6.1 All staff who create, receive, and use records in the course of their job are responsible for ensuring that records are managed appropriately. It is therefore likely that this post-holder will have responsibility for record-keeping as part of the role. Employees are required to be conversant with the Trust's policies and procedures on records management.
