<b>Duties &amp; Responsibilities:</b>	<p><b>Food Preparation:</b></p> <ul style="list-style-type: none"> <li>• Baking and decorating all cakes and tray bakes for the school canteen.</li> <li>• Basic food preparation e.g. vegetables, salads, cakes, pizza, pasta.</li> <li>• Preparation of all food types.</li> <li>• Cleaning and clearing of food production areas, including laundry and toilet areas.</li> </ul> <p><b>Food Service:</b></p> <ul style="list-style-type: none"> <li>• To prepare counters and dining areas for service</li> <li>• Service of hot and cold food and beverages</li> <li>• Replenishing and tidying of counters</li> <li>• Clearing and cleaning of all areas of the kitchen during preparation, during service and end of day cleaning.</li> <li>• Act on direction from duty manager during the course of the day. In a safe and purposeful manner.</li> <li>• Meet all daily targets at requested times for each service window</li> <li>• Perform all tasks in a safe and hygienic manner</li> <li>• Assist all staff where needed in a team environment with a “can do” initiative and attitude</li> <li>• Is enthusiastic and hard working in all duties</li> <li>• Have the ability to work under pressure and on their own in some aspects of the job</li> <li>• Able to solve and resolve any day to day issues without direct supervision</li> <li>• Organises and prioritises tasks and sees them through to completion</li> <li>• Be professional in contact with our customer base</li> <li>• Operate a till in biometric and money forms and take on the correct procedures in their operation</li> </ul>
