This is a unique opportunity for an exceptional CFO to lead a recently established Sikh Trust into the next stage of its development.

The Trust has 2 schools and is well respected in the local and wider Sikh community. The successful candidate will provide strong system leadership. The Trust was set up to create and sustain a family of academies which provide children an excellent education within a distinctively caring and supportive Sikh ethos. SSST (The Slough Sikh Trust) is the founding body of Khalsa Primary School.

SAT was formed on 30 December 2020. The Trust is comprised of two schools:

1. Khalsa Primary School (original school became a trust school on 1 February 2021)
2. Pioneer Secondary Academy (opened on 1 May 2022)

All of the schools in our Trust are learning communities where academic excellence sits within a Sikh faith inspired education. Our vision is for our pupils to have a coherent learning experience with clear learning pathways to higher education and employment. We aim to create a hub of excellence for students and young adults. Our objective is for all of our schools to be outstanding in all areas. We aspire to develop social responsibility through exemplary programs of outreach and service and to create a community bonded by open-heartedness, hope, compassion and care.

As a Trust, our single biggest and most important commitment is to pupils. We are committed to ensuring that every pupil, regardless of background or personal circumstance will be inspired to achieve their potential. Khalsa Primary School

Khalsa Primary School unique primary school: it is the founding school of Sikh Academies Trust, and it was judged 'Outstanding' in its recent Ofsted inspection in September 2023. The school is housed in a spacious and purpose-built building with exceptional resources. There is a Gurdwara on site.

Khalsa Primary School is a 2 form-entry school with nearly 500 pupils. Our results to date for Early Years, Phonics, KS1 and KS2 are significantly above the national averages. Places at Khalsa Primary School are in demand and community confidence in the school is very high.

Leaders have an unwavering vision that all pupils will achieve highly and become exemplary citizens. Leaders' belief that 'better never stops' has driven them to create an inspirational curriculum from Nursery to Year 6. In every subject, the key knowledge, skills and vocabulary that pupils must understand and learn are structured in a logical order. Teachers know precisely what pupils must learn. In the Nursery and Reception Years, teachers skilfully weave children's interests through the curriculum. Pupils in all year groups delight in their learning and are exceptionally well prepared for what comes next.

Chief Finance Officer - JOB DESCRIPTION

As the Sikh Academies Trust Chief Finance Officer, you will play a pivotal role in providing clear financial and commercial strategy and direction for the Trust. You will need to be fully aware of all funding and legislative changes that apply to the education sector and advise the Trust Board on strategic financial information to enable them to make informed decisions. You will be responsible for managing all budgeting and accounting activity; take on executive responsibilities as part of the senior management team; and the operational line management of the finance function, ensuring all systems are updated and reporting is timely and in line with required annual returns. In addition, you will coordinate the work of the external auditor and prepare and submit audited, statutory, consolidated accounts.

The ideal candidate will be commercially astute and have excellent communication and negotiation skills. Knowledge and/or experience of the school [academy sector is essential, and an understanding of special school budgeting and alternative provision would be beneficial. This will be a challenging environment, so we are looking for someone who is adept at building strong, positive relationships with a variety of stakeholders and can foster respect and trust easily.

This is a post that will change over time; the post holder will be responsive and proactive in the context of strategic priorities.

The Academy is designated by the Secretary of State as a school with a religious character. The school's within the Trust are Sikh Faith Schools and are to be conducted as a Sikh school in accordance with Rayat Maryda.

Role requirements

This post offers an exciting opportunity for an ambitious and enthusiastic professional to Role requirements This post offers an exciting opportunity for an ambitious and enthusiastic professional to join a new and growing multi academy trust. The Chief Finance Officer will provide leadership and management of all aspects of finance, as well as contributing to the strategic direction of the Trust.

All the work will be rooted in ensuring benefit to the learners and Finance communities the Trust serves.

As a key member of the Leadership Team, the Chief Finance Officer will play an important part in setting the direction of strategic development. This will include regular reporting to the Trust Board and the production of high quality reports to enable them to make informed decisions.

The Chief Finance Officer will keep ahead of funding and legislative changes that apply to the education sector and will provide the Board of Trustees with strategic financial information to enable them to make informed financial decisions.

The Chief Finance Officer will be responsible for the operational line management of the finance function and managing all the financial accounting and transactional finance for the Trust, ensuring all systems are up-to-date and reporting is timely and in line with required annual financial returns. They will lead the work of the finance team and to coordinate with the work of the external auditor to prepare and submit audited statutory consolidated accounts.

Robust systems, processes and controls will be implemented and a fixed asset register and risk register maintained. The Chief Finance Officer will monitor financial performance and will drive change within the finance operation of the Trust, bringing greater efficiency in the way the Trust carries out its business.

The Chief Finance Officer will regularly visit schools within the Trust to develop a good working knowledge of those schools and how they serve their communities. They will ensure good use of resources by utilising and developing capacity from within the Trust and contracting from outside the Trust where this is not available.

The Chief Finance Officer will line manage the Facilities and Operations Manager to achieve the successful sustainable management of the Trust sites, buildings and facilities.

In all their work the Chief Finance Officer will recognise that their prime responsibility is to the children, families and communities that the Trust serves.

Key Purpose:

- The overall purpose of this post is to provide professional leadership and management of financial services for the Trust.
- Be accountable for ensuring the provision of the financial reporting to enable the Trust to achieve its aims and objectives through the effective and efficient management of its financial resources.
- To promote best practice and to ensure compliance with the financial processes and procedures set out in the policies of the Trust and in accordance with the EFSA Academies Trust Handbook, and the requirements of the DfE and the EFSA.
- To take responsibility for the prompt and effective introduction of financial systems and processes in the Trust.
- The postholder will have a key role in the management of the Trust and will have effective responsibility for the following:
 - Financial Statements
 - Management Accounts
 - Financial Compliance
 - Budget Preparation
 - Financial Reporting
 - Income Generation
 - Financial monitoring - including payroll and staff pensions
 - Securing "best value" in all areas
 - Audit services (internal and external)
 - Other areas of work commensurate with the purpose of the post.

Financial Management:

- Ensure the Trust has appropriate financial systems in place and managing these in accordance with the agreed policies and timetable; ensuring accurate financial records are maintained and reported to the DfE, EFSA, Companies House and the Charity Commission.
- Prepare year end statutory Trust Trustees Report and Financial Statements.
- Submit Financial Statements in accordance with EFSA guidelines, following the Finance & Audit Committee and Trust Board approval.
- Prepare Value for Money Statement on behalf of the Accounting Officer.
- Devise appropriate accounting procedures to plan and monitor each Academy's 3 year budget plan.
- Produce timely, accurate and appropriate reports and financial forecasts for the Trust
- Finance & Audit Committee and Trust Board.
- Review cash flow for each school within the Trust.
- Liaise with Headteachers to ensure financial action plans are on track for implementation.
- Ensure timely and effective financial information to Trustees and provide general support to ensure the effective conduct of their business in accordance with the Articles of Association and financial regulations.
- Research and bid for additional funding to DfE for the Trust and in support of individual academies and assist with the financial monitoring of projects as they are agreed.
- To oversee the recovery of VAT.
- To oversee appropriate credit control processes thus ensuring that the payment of outstanding sums are received as swiftly as possible.
- To advise the Trust Board, LAB Governors and Headteachers on financial and budget matters.
- To provide training as required to meet the needs of the Trust.

Audit Services

- Advise the Executive Principal and the Board on external and internal audit arrangements as required by financial regulations and memoranda.
- Liaise with auditors and facilitate all audit arrangements
- Implement and monitor audit requirements.
- To undertake benchmarking exercises.

Business Planning

- Contribute to the development and review of a 3 year strategic business plan ensuring objectives are linked to the overall long term financial plan of the Trust.
- To manage special projects as required, particularly those concerned with income generation and to write bids for funding as required
- To make a significant contribution to the growth and development of the academies by maximising the use of financial resources, investment and generating sources of income for the academies.
- To contribute to development and review of the Business Continuity Plan for the Trust.
- To compile, monitor and review the Risk Register for the Trust.
