Job Title: Class & SEND Learning Support Assistant

Reporting To: Head Teacher

The Head Teacher is looking to recruit outstanding LSAs who share the vision for Cathedral Primary School as a centre of excellence for primary education, committed to inclusion and grounded in a strong musical tradition. We have a range of opportunities across EYFS/KS1 and KS2, and will look to fit candidates into the most suitable year group, dependent upon previous experience.

We are looking for candidates who are able to work closely with the Class Teacher and SENDCo to support the learning of groups or individual children, adapting learning tasks as required, ideally with experience of running small group interventions, as well as supporting children within a classroom setting.

The successful candidates will also ideally have experience of working with children with either ASC, Social, Emotional and Mental Health Needs or ADHD and associated needs.
