<b>Duties and responsibilities specific to the post</b>	<ul style="list-style-type: none"> <li>• To assist in the development of appropriate syllabuses, resources, schemes of work, marking policies and teaching strategies in the Curriculum Area and Department.</li> <li>• To contribute to the achievement of the school's development plan and its implementation.</li> <li>• To plan and prepare lessons.</li> <li>• To contribute to the whole school's planning activities.</li> </ul> <p><b>Curriculum Coordinator Responsibilities (<i>depending upon experience</i>)</b></p> <ul style="list-style-type: none"> <li>• Develop own expertise in the above subject areas</li> <li>• To keep abreast of the above subject areas through research, CPD etc</li> <li>• To act as a consultant to other staff, including the Headteacher</li> <li>• To produce in consultation with colleagues written policies and guidance; and lead staff in the discussion of policy and guidance</li> <li>• To oversee the effective use of curriculum resources in the subject areas detailed above</li> <li>• Ensure 'Best Value' in the procurement of curriculum resources in the subject areas detailed above</li> <li>• Ensure legal compliance with statutory curriculum guidance in the above subjects</li> </ul>
