Main Duties and Responsibilities

- Be an excellent classroom practitioner

- Being outward-facing, reading and researching current evidence to inform practice and pedagogy
- Taking risks to enable creativity and innovation in educational practice



- Planning engaging and relevant lessons collaboratively with colleagues, consistent with the school curriculum
- Using assessment information judiciously to adapt teaching so that pupils make good progress and address learning gaps
- Providing robust assessment information to inform pupil progress monitoring and to target intervention
- Directing the work of teaching assistants and other classroom support staff, where allocated
- Contributing to the delivery of CPD to staff, including INSET, as required
- Ensuring that parents/carers are well-informed about the curriculum, targets, children's
 progress and attainment, building effective relationships with parents/carers and dealing with
 day-to-day issues as they arise

General

- Work in a professional manner and with integrity and maintain confidentiality of records and information
- Maintain up-to-date knowledge in line with national changes and legislation as appropriate to the role
- Be aware of and comply with all Academy policies including in particular Health and Safety and Safeguarding
- Participate in the Academy Appraisal process and undertake professional development as required
- Adhere to all internal and external deadlines
- Contribute to the overall aims and ethos of the Spencer Academies Trust and establish constructive relationships with nominated Academies and other agencies as appropriate to the role
