In addition to the responsibilities of class teacher as set out in the appropriate Job Description and the School Teachers' Pay and Conditions document the Subject Leader will also undertake the following duties and responsibilities.

Responsible for: Leading Teaching and Learning in Mathematics across the school

### Core purpose of the Teaching and Learning Leader

To provide professional leadership and management for Mathematics, in line with the agreed approach, in order to secure high quality teaching, effective use of resources and high standards of learning and achievement for all learners.

### TEACHING, LEARNING AND STANDARDS

- To provide leadership for the effective delivery of Mathematics.
- To model and exemplify the characteristics of an excellent classroom practitioner.
- To evaluate the effectiveness of teaching and learning in Mathematics and progress towards meeting agreed targets across the school.
- To secure, in collaboration with the Head Teacher and senior colleagues, high standards of teaching and learning in Mathematics.
- To use data analysis effectively to contribute to school improvement.
- To continue to develop the Dunraven assessment model.
- To conduct regular learning walks and book looks and provide constructive feedback to teachers.
- To support the moderation of writing within the school and across the wider Dunraven Educational Trust.

### LEADERSHIP AND COORDINATION

- To assume the role of 'subject' consultant for colleagues.
- To monitor the quality of teaching and learning through detailed work scrutinies, planning scrutinies and through pupil conferencing, providing thorough diagnostic feedback to individual teachers.
- To demonstrate, by practical example as appropriate, effective ways of organising the teaching within Mathematics.
- To inform families/Governors when required about current thought and practice in Mathematics.
- To assist the Senior Team (ST) in ensuring the highest possible standards and quality of learning in Mathematics.

- To report to ST where concerns emerge with teaching practice.
- To work closely alongside the Mathematics Leads across Dunraven Educational Trust.
