Job Description



Job title: Coordinator of Learning - English (Key Stage 4)

Reports to: Head of Department - English

Location: Sir Joseph Williamson's Mathematical School

In addition to the contractual duties of a main scale teacher at this school:

Curriculum

- To ensure Key Stage 4 schemes of work, assessments, and resources are kept up to date and reviewed at appropriate intervals, with appropriate assessment criteria relating to 9-1 GCSE levels.
- To assist the Head of Department where appropriate in developing areas of the curriculum.
- To gain knowledge of developments in the curriculum, and in its methods of delivery, including new technologies, and in the assessment of the subject.
- To produce and share teaching resources as appropriate.

Assessment, recording and reporting

- To oversee the administration of all assessment and examinations within Key Stage 4.
- To co-ordinate the tracking and monitoring of pupils' progress through Key Stage 4, through termly data analysis. Pupil concerns should be identified, and interventions put in place.
- To conduct moderation/work scrutiny exercises within Key Stage 4 to ensure the consistency of assessment through the department.
- To undertake joint lesson observations with Head of Department as appropriate.
- To ensure all colleagues are following schemes of work and department/school protocols, and ensure photocopying of key resources is undertaken and provided to help ensure that this takes place.
- To advise staff in the completion of reports and progress grades within the department.

Safeguarding of students and Duty of care

All staff, regardless of role, level of seniority and location, have a responsibility to ensure the highest levels of safeguarding and promoting the welfare of our pupils, and we expect all our staff and volunteers to share this commitment. We must collectively create an environment where children feel safe to learn, play, and grow. Annual safeguarding training is offered to all staff at Leigh Academies Trust, and it is the staff member's responsibility to be aware of the most up to date guidance documented in the <u>Keeping Children Safe in Education document</u> (Department of Education).
