### The Role

As a Cover Supervisor at Charter Academy, you will cover the high-quality, rigorous work set for lessons that help to drive achievement and inspire a love of learning that extends beyond the classroom. You will be expected to supervise whole classes during the short-term absence of teachers, giving instructions for the lessons and ensuring good order is maintained and all pupils are kept to task.

- Report back to the teacher as appropriate using the schools agreed referral procedures on the behaviour of pupils during the class, and any issues arising.
- Promote the inclusion of all pupils within the classroom, being aware of and supporting difference, to ensure all pupils have equal access to opportunities to learn and develop.
- Set high expectations linked to classroom culture to promote learning so that all students are inspired, motivated and focused to reach their full potential.
- Manage behaviour effectively to create a safe, respectful and nurturing environment so that students can focus on learning
- Work collaboratively with both school and network colleagues as a committed team member
- Participate actively throughout the network, by attending relevant meetings, and, as appropriate, network-wide training and initiatives
- Support in working with colleagues, students and families to develop a strong school community
