- Reporting back as appropriate using the school's agreed referral procedures on the behaviour of students during the class, and any issues arising.
- Completing tracking sheets and information on student attendance and rewards.

## Support for the Curriculum

- Support the use of ICT where appropriate.
- Make appropriate use of equipment and resources.

#### Support to School

- Promote and safeguard the welfare of children and young persons you are responsible for or come into contact with.
- Assist with policies and procedures relating to child protection, health, safety and security, confidentiality and data protection and in particular the regulations relating to GDPR, reporting all concerns to an appropriate person.
- Ensure all students have equal access to opportunities to learn and develop.
- Liaise effectively with teachers/parents, welfare officers, health visitors and other professional staff as part of the routine consultative process.

- Assist with the supervision of students out of lesson times, including before and after school and at lunchtimes.
- Recognise own strengths and areas of expertise and use these to advise and support others.
