Introduction

We are a successful secondary school based in Brockworth, extremely close to junction 11a of the M5. The school has consistently been achieving excellent academic results over the past few years with the GCSE results of 2023 being in the top 1% of results in the country, as well as the highest results for any non-selective school in Gloucestershire. With the opening of our Sixth Form in September 2024, we are looking to increase our team with excellent members of staff that have a passion for supporting young people from all backgrounds to be the most successful they can be.

At Henley Bank High School, our aspiration is for all our staff and students to leave our school with practical wisdom gained through the teaching of intellectual, moral, civic and performance virtues. Job Description

The cover supervisor is a crucial role at Henley Bank High School, ensuring that excellent standards and routines are maintained despite teacher absence. This ensure the academic rigour and support of all students, allowing them to continually be successful.

The duties and responsibilities in this job description are not restrictive and the post holder may be required to undertake any other duties that may be required from time to time. Any such duties should not however substantially change the general character of the post.

Job Purpose

- To Provide short-term cover for absent teachers
- Supervising students ensuring they are engaged in the classwork and working in a calm working environment
- Helping students to become more independent in their learning
- Supervise and manage the behaviour of students whilst they are undertaking work, ensuring a constructive learning environment in accordance with the whole school behaviour policy

Main duties/responsibilities

- Establishing trust with students and interacting with them according to their individual needs
- Supervise work that has been set in accordance with the school policy
- Using the necessary resources that have also been provided
- When cover is not required, there will be an expectation to support other departments
- Collect completed work and return it to the appropriate teacher
- Ensure the room is left tidy and ready for the next lesson
- Report back on the lesson including any issues that arise during the lesson is communicated back to the appropriate teacher or relevant leader
- Record and report attendance in accordance with the school policy
- Promote the inclusion and acceptance of all in the classroom
- Deal with any immediate problems or emergencies according to the school's policies
- Follow school policies and procedures especially those related to child protection and health and safety
- Contribute to the overall ethos, work and aims of the school

Staff Development

- To continue personal development in the relevant areas including subject knowledge and methods
- To engage actively in the Performance Management process
- To participate in whole school CPD programmes
- To take part in the staff development programme by participating in arrangements for further training and professional development.

Safeguarding

- Be keenly aware of the responsibility for safeguarding children and to help in the application of the Safeguarding Policy within the school
- Comply with the school's Safeguarding Policy in order to ensure the welfare of children and young persons

Communications, Marketing and Liaison

1. Application

2. Shortlisting

Shortlisting will be finalised by **Monday 1st July 2024**. Shortlisted applicants will be invited by telephone to attend an interview and will receive an email inviting them to select the preferred interview time. Please ensure you enter your correct email address on your application form and provide a contact telephone number. References may be taken up after shortlisting. Please indicate clearly on your application form if you are happy for us to do so.

3. Interview Process

Interviews will be arranged as and when successful applications arrive, as the school reserves the right to conduct interviews prior to the closing date. Applicants will also be asked to undertake a practical test related to the knowledge and abilities in the Person Specification.

4. Feedback

Unsuccessful shortlisted applicants will have the opportunity for professional feedback during the week following the interviews.
