Main purpose:	To work under the guidance of teaching staff and within an agreed system of supervision, to implement work programmes with individuals/groups in or out of the classroom including the supervision of whole classes during the short-term absence of teachers.

	Manage the behaviour of pupils whilst they are undertaking this work to ensure a constructive environment.	
	Respond to questions from pupils about process and procedures.	
	Assist pupils to undertake set activities as appropriate.	
	Deal with any immediate problems or emergencies according to the schools policies and procedures.	
	Collect completed work after the lesson and return it to the appropriate teacher.	
	Report back as appropriate using the schools agreed referral procedures on the behaviour of pupils during the class and any issues arising.	
	Establish productive working relationships with pupils, acting as a role model and setting high expectations.	
	Promote the inclusion and acceptance of all pupils within the classroom	
	Support pupils consistently whilst recognising and responding to their individual needs.	
	Encourage pupils to interact and work co-operatively with others and engage all pupils in	

activities Promote independence and employ strategies to recognise and reward achievement of self-Provide feedback to pupils in relation to progress and achievement. Be responsible for keeping and updating records as agreed with the teacher, contributing to reviews of systems/ records as requested.
