This role is a cover teacher role, to cover PPA, ECT cover and for part time teachers. The teacher would be expected to plan, deliver and mark lessons taught, and given appropriate PPA for this. In addition, the teacher would plan and deliver interventions to struggling learners, and track their progress. - Participate in arrangements for preparing pupils for external tests

#### Whole-school organisation, strategy and development

- Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, so as to support the school's vision and values
- Make a positive contribution to the wider life and ethos of the school
- Work with others on curriculum and pupil development to secure co-ordinated outcomes
- Provide cover, in the unforeseen circumstance that another teacher is unable to teach
- Champion a subject and work with colleagues to develop its curriculum, observe and monitor the teaching and keep up to date with developments in that area
