#### **JOB DESCRIPTION – CURRICULUM LEADER, ASSISTANT HEADTEACHER**

**AIMS OF THE SCHOOL:** St Thomas of Canterbury Catholic Primary School is a popular school founded in 1886, boasting an excellent local reputation with facilities that provide an engaging working and learning environment. Our children are always expected to do their best and aim for excellence. St Thomas' is a 3 form entry school, located on an attractive site, catering for around 630 pupils from a community that embraces diversity.

**Responsible to:** The Headteacher, the Curriculum Leader is an employee of the Christus Catholic Trust Board and is required to carry out professional duties as detailed in this job description, and in Canon Law, the Trust Deed and Instrument of Government for the school (Articles of Association and Memorandum of Understanding for academies).

#### **1. Introduction**

- 1.1 This appointment is with the Trustees of the Christus Catholic Trust Board under the terms of the Catholic Education Service contract signed with the governors/trust as employers. The Trustees will predominantly aim to appoint a practising Catholic who, by personal example and professional leadership, will ensure that the Catholic ethos, rooted in the teachings of Jesus Christ and the Catholic Church, permeates all aspects of life in the school.
- 1.2 The appointment is subject to the current conditions of service for Curriculum leaders contained in the School Teachers' Pay and Conditions Document and other current education and employment legislation.
- 1.3 This job description may be amended at any time, following consultation between the headteacher and the Curriculum leader and will be reviewed annually.

#### **2 Core Purpose of the Curriculum leader**

- 2.1 To set the context, the core purpose of the Curriculum leader is to assist in providing professional leadership and management for a school. This will promote a secure foundation from which to achieve high standards in all areas of the school's work. To gain this success, a Curriculum leader must help establish high quality education by assisting in effectively managing teaching and learning and using personalised learning to realise the potential of all pupils. Curriculum leaders must assist in establishing a culture that promotes excellence, equality and high expectations of all pupils.

2.2 The core purpose of the Curriculum leader is to support the headteacher in ensuring that:

- the school is conducted as a Catholic school in accordance with the teachings of the Catholic Church and Canon Law, and in accordance with the Trust Deed of the Diocese of Brentwood;
- Religious Education is in accordance with the teachings, doctrines, discipline and general and particular norms of the Catholic Church;
- religious worship is in accordance with the rites, practices, discipline and liturgical norms of the Catholic Church;
- the design and delivery of the curriculum is broad, structured, coherent and relevant to the cultural diversity of our school community.
- the school provides high quality teaching and learning that leads to successful outcomes for pupils in terms of spiritual and moral growth, achievement, attitudes to learning, behaviour and personal development;
- the school promotes and safeguards the welfare of all children, enabling every child, whatever their background or their circumstances, to have the support they need to: be healthy; stay safe; enjoy and achieve; make a positive contribution; achieve economic well-being; recognise their own dignity and the dignity of others as children of God;
- all statutory requirements are met and the work of the school is effectively monitored, evaluated and reviewed.

### **General Duties and Responsibilities**

To carry out the duties of the Curriculum leader as set out in the current School Teachers' Pay and Conditions Document.
