Main purpose of the job:

To work with the Academy Council, Headteacher and other academy and Trust leaders to ensure the very best education for the students, through achieving the school and Trust aims and objectives. In particular, to develop and manage curriculum, teaching and learning policies and lead all provision of the school in line with its Social Emotional and Mental Health (SEMH) designation. To deputise for the Headteacher as and when required.

Key duties and responsibilities

Accountable to the Headteacher, Trust executive and the Academy Council for:

- sustaining the aims and objectives of the school and establishing the policies through which they will be achieved; managing staff and resources to that end; and monitoring progress towards their achievement across all settings;
- working to maximise students' progress towards their full potential;
- liaising with key stakeholders to support school improvement.

Strategic direction and development of the school:

To work with the Academy Council, Headteacher, school workforce and school communities to contribute to development of the strategic view for the school in each community and analyse and plan for the future needs and further development of the school in a local, national and international context.

- To develop overall aims and objectives for the school as a whole and policies for their implementation;
- To support the Headteacher in creating an ethos and provide educational vision and direction which promotes effective teaching, successful learning and achievement by pupils and sustained improvement in their spiritual, moral, cultural, emotional and physical development, and prepares them for the opportunities, responsibilities and experiences of adult life;
- To work with the Headteacher to develop and implement a strategic plan, underpinned by sound financial planning, which identifies priorities and targets for ensuring that pupils achieve high standards and make progress, increasing teachers' effectiveness and securing school improvement;
- To ensure that all those involved in the school across all sites are committed to its aims, motivated to achieve them and involved in meeting short, medium and long term objectives and targets which secure the educational success of the school;
- To ensure that the organisation of the school support its vision and aims;

- To ensure that policies and practices take account of national, local and school data, inspection and research findings; and
- To monitor, evaluate and review the effectiveness of policies, priorities and targets of the school in practice and take action if necessary.

Teaching and Learning

To work with the Headteacher and Academy Council to secure and sustain effective teaching and learning throughout all sites of the school and to monitor and evaluate the quality of teaching and standards of pupils' achievement, using benchmarks and setting targets for improvement.

- To ensure that all pupils receive a good quality education through appropriate programmes designed to promote good learning in a safe and healthy school environment;
- To ensure a consistent and continuous provision-wide focus on pupil's achievement, using data and benchmarks to monitor every pupils' learning and progress;
- To ensure that learning is at the centre of strategic planning and resource management;
- To establish consistent, creative, responsive and effective approaches to learning and teaching;
- To promote, demonstrate and ensure a culture and ethos of challenge and support where all pupils can achieve success and become engaged in their own learning;
- To be able to demonstrate, articulate and monitor high expectations and set stretching targets for the whole community;
- To be able to devise and implement strategies which secure high standards of behaviour and attendance;
- To devise and implement a diverse, flexible curriculum and implement an effective assessment framework;
- To be able to take a strategic role in the development of the new and emerging technologies to enhance and extend the learning experience of pupils
- To monitor, evaluate and review classroom practice across all sites and promote improvement strategies to ensure that underperformance is challenged at all levels and ensure effective support and intervention; and
- To ensure holistic, child centred support is in place which empowers children and their families and enables the development of healthy, socially inclusive behaviours.

Leading and managing people

To lead, motivate, support, challenge, hold to account and develop other people in order to secure improvement:

- To maximise the contribution of all staff across all sites
- to improve the quality of education provided and standards achieved and ensure that constructive working relationships are formed between staff and pupils;
- To plan, allocate, support and evaluate work undertaken by groups, teams and individuals, ensuring clear delegation of tasks and devolution of responsibilities in a manner consistent with their conditions of service, ensuring a reasonable balance for teachers and other members of staff, in work carried out in school and work carried out elsewhere;

- To sustain effective systems for the management of staff performance, incorporating appraisal and targets for teachers (including targets relating to pupils' achievement);
- To ensure that all staff receive regular appraisal and performance management as per the Trust's policies and procedures;
- To ensure that trainees and newly qualified teachers are appropriately trained, monitored, supported and assessed in relation to the standards for Qualified Teacher Status and the Teacher Standards; and
- To maintain an ethos of relationship based practice across the school which values the contribution that enjoyment can make to achievement.

Efficient and effective deployment of people and resources

To support or deputise for the Headteacher in the deployment of people and resources efficiently and effectively to meet specific objectives in line with the school's strategic plan and financial context:

- To work with the Headteacher, Academy Council and senior colleagues to recruit staff of the highest quality available;
- To work with senior colleagues to deploy and develop all staff, across all sites effectively in order to improve the quality of education provided;
- To support the Headteacher on the adoption of effective procedures to deal with the competence and capacity of staff in partnership with the Trust;
- To undertake responsibilities as defined in the Trust Health and Safety Policy;
- To ensure that appropriate risk assessments are undertaken across all sites before sanctioning and participation in any potentially hazardous activity;
- To manage, monitor and review the range, quality, quantity and use of all available resources in order to improve the quality of education, improve pupils' achievements, ensure efficiency and secure value for money; and
- To ensure that staff are encouraged to undertake CPD activity which increases their knowledge and understanding of cultural diversity and racism and how racism can be combated in a classroom setting.

Accountability

To be accountable for the efficiency and effectiveness of the school to the Headteacher, Trust CEO, Trust Board and others, including pupils, parents, staff and the local community:

- To provide information, objective advice and support to the Headteacher to enable them to meet their responsibilities for securing effective teaching and learning and improved standards of achievement and for achieving efficiency and value for money;
- To develop an organisation in which all staff across all sites recognise that they are accountable for the success of the school;
- To devise and present a coherent and accurate account of the school's performance in a form appropriate to a range of audiences, including parents, governors, the Trust Board, the local community, Ofsted and others, to enable them to play their part effectively;
- To ensure that parents and pupils are well-informed about the curriculum, attainment and progress and about the contribution that they can make to achieving the school's targets for improvement;
- To provide information about the work and performance of staff where it is relevant to their future employment; and
- To ensure that the school meets and maintains the standards for safeguarding under Section 175 of the 2005 Education Act.

Strengthening Community

- To establish and enable a school culture and curriculum which takes account of the richness and diversity of the school's community;
- To enable and promote positive strategies for challenging racial and other prejudice and dealing with racial harassment;
- To ensure learning experiences for pupils are linked into and integrated with the wider community;
- To ensure a range of community-based learning experiences and opportunities;
- To work in partnership with other agencies in providing for academic, spiritual, moral, social, emotional and cultural well-being of pupils and their families;
- To seek opportunities to invite parents and carers, members of the community, business or other organisations into the school to enhance and enrich the school and its value to the wider community;
- To be able to contribute to the development of the education system by, for example, sharing effective practice, working in partnership with other schools and leading and promoting innovative initiatives;
- To co-operate and work with relevant agencies to protect children;
- To ensure that the school promotes effective links with the local community and continues the development of close liaison with other local primary, secondary and special schools; and
- To support the Headteacher in ensuring that the school offers appropriate extended services.
