## **Main Duties**

- Set up resources / materials / equipment for lessons.
- Order and maintain sufficient supplies of materials and equipment to enable delivery of lessons and assist others in their use.
- Safely and securely store allocated equipment and materials to prevent unauthorised access / misuse.
- Clean and undertake basic maintenance of equipment as needed and as directed to ensure that it is clean and in good working order.
- Perform duties in line with health and safety regulations and take action where hazards are identified, including reporting any serious hazards to line manager
- Undertake record keeping, as directed.
- Secure and work with hazardous materials.
- Provide clerical and administrative support as directed.
- Ensure the safe treatment and disposal of used materials, including hazardous substances, and respond to actual or potential hazards.
- Under guidance sets up equipment and demonstrations for use by others.
- Undertakes routine equipment maintenance and stock ordering when requested.

## Professional standards and development

- Take responsibility for and participating in continuing professional development.
- Be a role model to students through appropriate personal presentation and professional conduct.
- Support all the School's policies and ethos.
- Establish effective working relationships with professional colleagues both in school and as part of the school's learning community and network.
- Responsible for the health, safety and welfare of self and colleagues in accordance.
  with the School's Health and Safety policies and procedures and current legislation.
- Reflect on own professional practice.
- Take responsibility for and participating in continuing professional development.
