JOB DESCRIPTION

JOB PURPOSE:

To contribute to the development of a strong, effective Academy with an emphasis on promoting a culture of educational excellence, within a caring and secure environment enriched with the values of discipline, mutual care and respect which extends beyond the Academy into the wider community.

JOB SUMMARY:

1. Devise and implement a development plan for the Departmental staff with clear annual targets using up to date performance data.
2. Develop, demonstrate and disseminate across the Academy a range of strategies for outstanding teaching and learning to raise the achievement of the subjects, and of different students.
3. Sustain and enhance attainment in designated subjects within the Department by embedding innovative assessment for learning tools.
4. Develop and manage the introduction of new and revised curricula.
5. Assist in the development of teaching staff, providing support where necessary.
6. Plan, support and deliver intervention and enrichment programmes outside of school hours to support learning and achievement by all students.
7. Demonstrate commitment to professional development of self and others by undertaking and leading professional learning provision.
8. Liaise with a range of educational partners within the Academy and beyond to support the progress and attainment of students within the Department.
9. Actively engage with parents to ensure students' learning extends to their home life.

KEY RESPONSIBILITIES AND ACCOUNTABILITIES

Please note 'department' or 'subject' relates to any departments/subjects of responsibility.

1. Strategic Direction and Development of the Academy

- 1.1. Provide inspiring and purposeful leadership for the students within a caring and secure environment.
- 1.2. Work in partnership with the Principal, Senior Leadership Team, Local Governing Body, Star Central, staff, students and parents in generating the ethos and values which underpin the Academy enriched by mutual care and respect extending into the local community.
- 1.3. Work within the overall aims and objectives of the Academy.

- 1.4. Promote and deliver the priorities and policies of the Academy by contributing to School Improvement and Development Planning, by consistently and persistently implementing agreed policies and initiatives and adhering to the Academy's ethos within and beyond the Academy.
- 1.5. Liaise as required with a range of educational partners, internal and external, to underpin the raising of student attainment.
- 1.6. Support the Academy's home and community liaison work through the appropriate participation in events.

2. Leadership

- 2.1. Line manage other TLR holders within the Department and hold overall responsibility for the performance of all staff within the department.
- 2.2. Lead the development of the Key Stage 3, 4 and Key Stage 5 curriculum across the Department.
- 2.3. Uphold Trust Quality Standards across the Department.
- 2.4. Ensure that all subjects within the Department deliver outstanding levels of achievement and attainment.
- 2.5. Lead, train, coach and develop colleagues in the Department.
- 2.6. Assist colleagues in the planning and delivery of the schemes of work and provide guidance on the choice of appropriate teaching and learning methods to meet the needs of the subjects, and of different students.
- 2.7. Guide and support colleagues in the management of students in the classroom in line with the Academy's Behaviour Policy.
- 2.8. Recognise and utilise the strengths of each member of the Department by differentiating and delegating tasks appropriately.
- 2.9. Hold departmental meetings and keep records of matters discussed and decisions taken.
- 2.10. Ensure that work is provided for classes of absent colleagues and that cover is arranged in accordance with the Academy's agreed procedures.
- 2.11. Liaise with the Principal on present and future departmental staffing matters including recruitment, induction, current responsibilities, professional review and development.
- 2.12. Support the Academy's programmes for New Staff induction, ECTs Induction and Initial Teacher Training.
- 2.13. Take a lead role in the professional review of colleagues in the Department.

3. Teaching and Learning

- 3.1. Create and maintain an environment and a code of behaviour that promotes and secures good teaching, effective learning and high standards of achievement.
- 3.2. Develop, use and apply subject expertise to secure appropriate and consistent progress for all students across the range of background and ability.
- 3.3. Develop and apply a range of effective teaching and learning strategies to raise the achievement of students, maintaining an up-to-date knowledge of good practice in Teaching and Learning.
- 3.4. Deliver after-school support and pre-exam intervention sessions as and when required to ensure the highest levels of achievement and attainment. Hold whole day intervention sessions in the holidays to support and maximise progress where needed.

- 3.5 Deliver subject enrichment activities for learners to consolidate and promote learning in Vocational subjects.
- 3.6 Observe and be observed by colleagues and utilise feedback effectively.
- 3.7 Use performance data to inform planning and teaching, including the evaluation of students' progress and setting of appropriate targets for improvement.
- 3.8 Create and maintain an effective partnership with parents to support and improve student community achievement and personal development.

4. Management of Students

- 4.1 Organise students into teaching groups.
- 4.2 Provide schemes of work that ensure continuity and progression in the subjects for all students, including those of high ability and those with learning support needs.
- 4.3 Identify, after consultation with colleagues, able and talented students and those with learning support needs and arrange appropriate action and intervention.
- 4.4 Devise a departmental policy for rewarding achievement in line with the Academy's Rewards Policy.
- 4.5 Promote Personalised Learning by encouraging the use of teaching and learning strategies which develop the competence and confidence of every student.
- 4.6 Organise the setting and marking of school examinations and supervise entries for public examinations.
- 4.7 Provide careers advice relevant to the Department.
- 4.8 Initiate and foster extra-curricular activities which widen students' appreciation of the subjects and contribute to the general life of the Academy.

5. Management of Resources

- 5.1 Estimate and manage the departmental budget.
- 5.2 Assess needs and priorities in accommodation, advising the Principal on the optimum use of existing rooms as well as future requirements.
- 5.3 Plan and administer the development and storage of equipment, books and other resources.
- 5.4 Ensure all internal units are stored securely and that students follow exam board guidelines for use of resources.
- 5.5 Advise on security needs of the Department and keep a record of stock and equipment.
- 5.6 Supervise the departmental area, fabric, facilities and resources.
- 5.7 Assess all areas of departmental responsibility from a Health and Safety viewpoint in liaison with the Business Manager.
- 5.8 Ensure that departmental rooms present stimulating environments which help to influence students' attitudes positively towards the subjects.

6. Planning and Development

- 6.1 Plan and co-ordinate the work of the staff in the Department and disseminate information efficiently.
- 6.2 Plan, implement and review syllabuses, teaching schemes, assessment policies and reporting procedures in accordance with Academy aims, policies and practices.
- 6.3 Set expectations and targets for staff and students in relation to standards of student achievement and the quality of teaching.

- 6.4. Keep abreast of current developments in the subject areas and adapt curriculum content and methods of teaching and examining as appropriate.
- 6.5. Consider such developments in the context of the Academy's philosophy for the curriculum as a whole.
- 6.6. Act as quality nominee for the Vocational offer at the Academy.

7. Monitoring and Evaluation

- 7.1 Analyse and interpret relevant national and Academy data to inform policies, practices and teaching methods.
- 7.2 Monitor teaching standards in the Department and use this analysis to identify both effective practice and areas for improvement.
- 7.3 Ensure students' work is regularly assessed and that homework is in line with Academy policy.
- 7.4 Use information gained from assessment, recording and reporting procedures to generate further improvement in student achievement.

8. Communication and Liaison with Other Colleagues

- 8.1 Represent the subjects, the Department or the Academy in appropriate meetings.
- 8.2 Ensure the line manager and Principal are informed on all issues concerning the Department.
- 8.3 Liaise with the business support team in all matters concerning administration, health and safety and external agencies.
- 8.4 Liaise with the pastoral team in respect of student records, rewards and sanctions.
- 8.5 Liaise with the examinations team in issues relating to external examinations.
- 8.6 Maintain effective relationships with other Middle and Senior Leaders in the Academy.
- 8.7 Maintain appropriate links with teaching colleagues in all sections of Star Schools.
- 8.8 Liaise with other schools, post 18 education providers and local employers where appropriate.
- 8.9 Maintain appropriate links with feeder schools.

9. Communication with Parents and the Wider Community

- 9.1 Establish a partnership with parents to involve them in their child's learning of the subjects.
- 9.2 Provide information for parents about curriculum, attainment and progress.
- 9.3 Ensure that the Department is represented at Consultation Evenings.
- 9.4 Oversee the departmental input to Personal Records for students.
- 9.5 Assist the pastoral support teams in preparing extra information for parents, when requested, on the attainment, progress and effort of individual students.
- 9.6 Develop effective links with the wider community, including business and industry, in order to extend the subject and enhance teaching and learning.

10. Other Responsibilities

- 10.1 Promote the Trust's vision of 'nurturing today's young people, inspiring tomorrow's leaders'.
- 10.2 Champion the Trust's values of 'Service', 'Teamwork', 'Ambition' and 'Respect'.
- 10.3 Contribute to the wider life of the Trust and the Star community.
- 10.4 Contribute to the wider life of the Academy and its community through out-of-hours and partnership work.
- 10.5 Take responsibility for promoting and safeguarding the welfare of the children and young people in the Academy.
- 10.6 Carry out any such duties as may be reasonably required by the Principal or the Trust.

11. Records Management

- 11.1 All staff who create, receive, and use records in the course of their job are responsible for ensuring that records are managed appropriately. It is therefore likely that this post-holder will have responsibility for record-keeping as part of the role. Employees are required to be conversant with the Trust's policies and procedures on records management.
