EMPLOYER INVOLVEMENT

- Support the learner to undertake practical work tasks and gain experience towards competence Support the apprentice to complete a minimum of 20% off the job training
- Work with the college to monitor and review progress
- Support the apprentice through the end point assessment once they are ready
- Giving responsibility for children's personal care
- Communicating with carers/parents
- Provide access to policies and procedures
- Allocate a mentor to the apprentice
