One of the strengths of the LET Education Trust is school improvement, with a range of high-quality SLEs able to provide support where it is needed, both within and beyond the Trust. We play a part in Initial Teacher Training as part of our remit through the Embrace SCITT. We have successfully trained primary and secondary teachers over the last 10 years with a large number employed locally and within the LET Education Trust.

# Safeguarding at Huncoat

# Ofsted at Huncoat

We have recently undergone an Ofsted inspection in December 2024 and maintained the 'Good' standards identified at the previous inspection. Here are some snippets from the report. We are very proud of our school.

"Pupils are happy at Huncoat Primary School. The school's vision that everyone should have a 'can-do attitude' is a sentiment shared by all. Staff feel valued, pupils feel safe, and trustees and governors offer strong support. A set of ambitious values underpins the school's work. These values include respect, cooperation and determination.

All staff have high expectations of pupils, including pupils with special educational needs and/or disabilities (SEND). Pupils rise to these high expectations and achieve well.

Pupils are polite, kind and considerate to each other. They are well supported by staff, who help them if they have any worries or problems. From early years to Year 6, pupils are taught to cooperate with and support one another. Pupils respond well to the school's high aspirations for their conduct. Staff provide effective support for pupils who need help with managing their emotions.

Pupils enjoy a wide range of activities that make a strong contribution to the development of their talents and interests. For example, they learn to play musical instruments and visit inspiring events such as theatre productions. Pupils at Huncoat have a voice. This is realised through the pupil parliament, which makes a strong contribution to initiatives throughout the school."
