English is a successful subject at Tomlinscote and last year it achieved a progress 8 of +0.46 with the number of children gaining grades 7+ surpassing national figures for consecutive years.

The English department has a collaborative approach to teaching and learning with dedicated opportunities for staff to develop professionally throughout the year. Students are able to regularly take part in extra curricular activities and we pride ourselves on the inclusive opportunities we offer to children.
