**PRINCIPAL ACCOUNTABILITIES:**

1.	<b>Duties</b> <b>Teaching and Managing Pupil Learning</b> <ul style="list-style-type: none"><li>• Ensure effective teaching of whole classes, groups and individuals so that teaching objectives are met, momentum and challenge are maintained, and best use is made of teaching time.</li><li>• Use teaching methods which keep pupils engaged, including stimulating pupils' intellectual curiosity, effective questioning and response, clear presentation and good use of resources.</li><li>• Set high expectations for pupils' behaviour, establishing and maintaining a good standard of discipline through well-focused teaching and through positive and productive relationships.</li></ul>
2.	<b>Planning and Setting Expectations/Pupil Achievement</b> <ul style="list-style-type: none"><li>• Identify clear teaching objectives, content, lesson structures and sequences appropriate to the subject matter and the pupils being taught.</li><li>• Set appropriate and demanding expectations for pupils' learning and motivation. Set clear targets for pupils' learning, building on prior attainment.</li><li>• Identify pupils who have special educational needs, and know where to get help in order to give positive and targeted support. Implement and keep records on Individual Education Plans (IEPs).</li></ul>
3.	<b>Assessment and Evaluation</b> <ul style="list-style-type: none"><li>• Assess how well learning objectives have been achieved and use this assessment for future teaching.</li><li>• Mark and monitor pupils' class and homework, where given, providing constructive oral and written feedback, setting targets for pupils' progress.</li><li>• When applicable, understand the demands expected of pupils in relation to the National</li></ul>

	Curriculum.
4.	<b>Relationship with Parents and the Wider community</b> <ul style="list-style-type: none"> <li>• Prepare and present informative reports to parents.</li> <li>• Provide opportunities to develop pupils' understanding by relating their learning to real examples, recognising that learning takes place outside the school context.</li> <li>• Liaise with agencies responsible for pupils' welfare.</li> </ul>
5.	<b>Manage Own Performance and Development</b> <ul style="list-style-type: none"> <li>• Take responsibility for their own professional development and to keep up to date with research and developments in pedagogy and in the subjects they teach.</li> <li>• Share corporate responsibility the implementation of school policies and practices.</li> <li>• Set a good example to the pupils they teach in their presentation and their personal conduct.</li> <li>• Evaluate their own teaching critically and use this to improve their effectiveness.</li> </ul>
6.	<b>Managing and Developing Staff and Other Adults</b> <ul style="list-style-type: none"> <li>• Establish effective working relationships with professional colleagues including, where applicable, associate staff.</li> </ul>
7.	<b>Managing Resources</b> <ul style="list-style-type: none"> <li>• Select and make good use of textbooks, ICT and other learning resources which enable teaching objectives to be met.</li> </ul>
8.	To promote and safeguard the welfare of children and young person's in accordance with Safeguarding Children in Education under the provisions of the Education Act 2002 section 175.

<b>GENERAL:</b>	
1.	The above principal accountabilities are not exhaustive and may vary without changing the character of the job or level of responsibility.
2.	The above duties may involve having access to information of a confidential nature, which may be covered by the Data Protection Act. Confidentiality must be maintained at all times.
3.	The postholder must be flexible to ensure the operational needs of the Council are met. This includes the undertaking of duties of a similar nature and responsibility as and when required, throughout the various work places in the Council.
