## Overall purpose of job:

To work under the direction of teachers and other colleagues to support teaching and learning by working with individual pupils or small groups of pupils

## Main duties and responsibilities:

- 1. Under direction and guidance, work with individual pupils or small groups of pupils as directed, to implement planned learning activities
- 2. Support pupils in class or other locations within school as and where required, under the direction of the class teacher
- 3. Participate in the planning and evaluation of learning activities, adapting work and activities as directed
- 4. Assist with the assessment and monitoring of pupil progress by providing feedback on pupils' achievements and progress, including keeping accurate records
- 5. Assist with the development of individual plans for pupils by providing feedback
- 6. Support pupils with their personal and social development
- 7. Provide information and attend meetings with staff, parents/carers and other external professionals as and when required, under the guidance of the class teacher, Phase Leader, SENDCO or member of SLT
- 8. Understand and support independent learning and inclusion of all students
- 9. Accompany other staff and pupils on school visits, trips and in other activities outside of the classroom, taking responsibility for specific pupils or small groups as directed
- 10. Undertake supervision at break and lunchtimes, including preparing snacks and food for pupils, assisting with clean down afterwards as and when required
- 11. Undertake routine administrative and clerical tasks as and when required
- 11. Assist pupils with eating, dressing and personal hygiene where required, whist also encouraging independence



12. May be given areas of responsibility within the school that are appropriate to specific skills, knowledge and experience, for example in maintaining curriculum resources in a particular subject area, preparing displays, etc. General: 1.
