## JOB DESCRIPTION: FRENCH UQT PPA COVER

EFFECTIVE: September 2025

This post holder is required to carry out the duties of a French UQT providing PPA cover from Year 1 -6 legislation and any duties as may be reasonably directed by the Head teacher. This job description may be amended at any time following discussion between Head and member of staff, and will be reviewed annually.

### Teaching Responsibility and Key Tasks:

- To plan and teach stimulating and interesting learning based on the MFL National Curriculum.
- To be responsible for the on-going review of the primary school's MFL curriculum and related schemes of work.
- To support the development and on-going review of the primary school's MFL assessment procedures in liaison with class teachers.
- To work effectively to ensure that there is progression across the year groups.
- To take every opportunity of developing children's basic social and educational skills and to assist in the development of their listening and speaking skills.
- To plan for a range of abilities so that all children reach their potential.
- To lead and implement MFL strategies throughout the school and to co-ordinate all MFL events including extra-curricular, clubs and assemblies.

### Classroom Management and Organisation:

- To teach and actively promote the schools core values and positive reinforcement approach to behaviour management
- To follow the schools nurturing principles to maintain a well-ordered, calm environment that is stimulating and purposeful.
- To ensure that all equipment is organised and accessible to children so that it encourages independent learning.
- To organise an inclusive learning environment.
- To maintain assessment records as specified in the School's assessment schedule.
- To direct Teaching Assistants whilst french learning is taking place and to monitor tasks they are expected to undertake.

### Safeguarding and Inclusion

- To be individually responsible for promoting and safeguarding the welfare of children.
- To take account of each child's home language and culture ensuring this is reflected in displays, materials and throughout the curriculum.
- To provide a safe, welcoming and positive atmosphere for parents that will establish strong links with the School.
- To comply with policies and procedures relating to Child Protection, Health & Safety, security, confidentiality and data protection and to ensure that the DSL or DDSL is made aware and kept fully informed of any concerns which the individual may have in relation to safeguarding and/or child protection.
- To be fully aware of and understand the duties and responsibilities arising from the Children's Act 2004 and Working Together in relation to child protection and safeguarding children and young people as this applies to the individual's role within the organisation.

- To attend and contribute to CPD sessions.
- To be proactive in identifying areas for career and self-development.
