Job Purpose:

The successful applicant will be expected to work effectively to help teaching staff provide excellent learning opportunities for our children. The role requires working with class teacher(s) to raise the learning and attainment of pupils, as well as providing support to pupils, individually or in groups, so they can access the curriculum, take part in learning, and experience a sense of achievement

Main Duties and Responsibilities

The Post holder working to this job description may undertake any of the following main duties and responsibilities.

- Support the classroom teacher in delivering the curriculum
- To cover and lead class teaching as and when appropriate
- Supporting SEND children on a 1 to 1 basis, when required
- Support pupils' learning activities, attend to additional learning needs, and aid development
- Use you own area(s) of expertise to contribute to the planning and preparation of learning activities, and to plan your own role in learning activities
- Use allocated time to devise clearly structured activities that interest and motivate learners and advance their learning
- Plan how to support the inclusion of pupils in the learning activities
- Support pupils in their individual learning and development
- Assist with the care and support of pupils
- Contribute to the health and well-being of pupils
- Establish and maintain relationships with individual pupils and groups
- Contribute to the management of pupils' behaviour
- Assist pupils in carrying out schemes of work and programmes set by teaching staff
- Maintain appropriate liaison with parents and staff
- Assist with the provision for specialist support for individuals and groups of children with behaviour, social, emotional and learning needs
- Maintaining accurate records
- To provide duty supervision at designated breaks and afterschool clubs, if required
- Maintain confidentiality
- Assist with the presentation of classroom displays
- Undertaking any other duties that may be reasonably regarded as commensurate with the grade and purpose of the post
- Take responsibility for a group or class of children as directed by the teacher
- Interact with and support children, providing them with a secure environment in which to learn
- Produce teaching resources
- Organise learning materials and resources, and making imaginative use of resources
- Ensure that the health and safety of children and staff is maintained during all activities, both inside and outside the school
- To attend morning briefings, staff meetings and parents' evenings as required
- Participate in training and other learning activities and performance development as required to



meet individual pupil and staff needs
