Key purpose of the role

Enable the Trust to realise its mission to 'Transform lives, strengthen communities and make the world a better place' by ensuring inspirational and forward-thinking governance which instils excellence in all areas of the organisation's work

#### Your responsibilities

- Provide leadership which ensures sector leading and proactive governance at all levels of the organisation.
- Develop a culture of effective communication between the members, Board, its committees, and the executive leadership team which positively echo into all areas of the organisation enhancing the perception of governance as a vital and constructive element of our collective success.
- Lead on the development of all critical instruments of governance including, ensuring alignment with the Trust's Articles of Association and Scheme of Delegation.
- Ensure the Trust operates in compliance with the Academies Handbook, Charity Commission, and Department for Education (DfE) requirements.
- Promote governance that strengthens communities and aligns with the Trust's vision and values
- Provide advice and support to the Members, Trust Board and the Executive on governance matters.
- Lead the governance team in a way that is collaborative and supportive, promoting
  continuous improvement and best practices in governance. Ensure that governance
  arrangements are well-coordinated and that meetings are effectively managed at all

- Develop and implement a comprehensive induction and training program for Trustees and Governors.
- Work with the Executive to ensure that all areas of strategic development, risk and assurance are appropriately understood at all levels.




## **Our Journey**
