The PE Department at LRGS enjoys an extremely high reputation within the school and in the local community. It has a strong sporting and academic tradition.

The Head of PE is expected to be a well-qualified PE graduate who can teach PE to high A-level standards. He/she will lead this experienced and successful department with enthusiasm and vision. In particular, as Head of Physical Education, he/she will be responsible for the following:

Teaching and Learning

- The teaching and learning of PE at LRGS and the maintenance of the highest possible standards of pedagogy within the department.
- The progress of individual pupils in PE including the maintenance of records, taking action when necessary with intervention strategies.
- The development of schemes of work in all year groups, taking into account the National Curriculum where appropriate, and the implementation of GCSE and A-level specifications.
- The development, maintenance and sharing of high quality teaching and learning resources.
- The administration and coordination of internal and external PE exams.
- Update the content of the PE area of the school website, including promotional materials for options and oversee department sports social media apps.

Staffing

- To inspire and enthuse members of the team, with a clear vision for the future direction of the PE department.
- The appraisal / performance management of departmental colleagues against the teaching standards.
- Planning, recording, promoting and monitoring the professional development of PE department staff.
- The allocation of staff to PE sets.
- Holding, chairing and writing minutes for regular departmental meetings.
- Leading the induction of new members of staff.
- To act as a role model to others, demonstrating high standards of professionalism in all aspects of leadership.

Resources

The PE budget and the purchasing of resources;

• The appearance of the PE rooms including departmental displays in the sports facilities and classrooms to create a stimulating learning environment.

Other Duties

- The maintenance of a departmental handbook, including the updating and implementation of policies and a knowledge of the Ofsted framework.
- Health and safety issues relating to timetabled PE, in particular continued updating of risk assessments.
- The preparation annually of an examination results analysis report and the Quality Improvement Plan.
- The contribution of PE to the school's co-curricular programme, and the running of clubs at lunch times and after school in the sports hall and pool in liaison with other staff associated with the running of those clubs.
- The co-ordination and organisation of Open Day.
- To represent the department at curriculum forum meetings.
- To advise 6th Form pupils who wish to study PE and related subjects at University as they prepare for applications, aptitude tests and interviews.
- To lead and promote, alongside the Head of Games, on whole school sports events, eg swimming gala, sports day.
