### **Student Learning**

- 1. To plan and prepare courses and lessons for the students in classes assigned to you.
- 2. To assist in the development of appropriate syllabuses, resources, schemes of learning, marking and feedback approaches and teaching strategies in the relevant subject areas.
- 3. To contribute to the subject area's evaluation, review and development planning and its implementation.
- 4. To ensure the effective and efficient deployment of learning and teaching support in your classroom.
- 5. To maintain appropriate records and to provide relevant accurate and up to date subject area information and for SIMS as required.
- 6. To monitor student progress and use data to inform teaching and learning.
- 7. To communicate effectively with students.
- 8. To communicate effectively with the parents of students.
- 9. To take part as required in Progress Evenings, Open Evenings, special events and liaison events with other schools (eg, partner primary schools).
- 10. To contribute to the development of effective links with external agencies to enhance the learning process.
- 11. To maintain good order and discipline and apply the Behaviour for Learning Policy of the school so that effective teaching and learning can take place.

## **Teaching**

- 1. To teach students according to their learning and educational needs, including the setting and marking of work to be carried out in school and elsewhere.
- 2. To have high expectations of the students in your classes.
- 3. To ensure a high-quality learning experience for students.
- 4. To prepare and update teaching materials.
- 5. To use a variety of teaching and learning methods that will stimulate learning.
- 6. To encourage good practice with regard to standards and quality of work and homework, punctuality and behaviour.
- 7. To expect and encourage good manners and respect for other people.
- 8. To assess, record and report on the attendance, progress, development and attainment of students and to ensure records are kept as required.
- 9. To mark, grade and give written/verbal feedback to the student as required and to engage learners in acting upon the feedback.
- 10. To provide, or contribute to, oral and written assessments reports and references relating to individual students or groups of students, including Annual Reviews for SEND students.

## **Staff Learning**

- 6. To alert staff as appropriate to changes in students' specific circumstances as they arise
- 7. To communicate as appropriate with parents of the students.
- 8. To undertake duty supervision before school, breaks, after school and detentions as directed.

- comply with any reasonable request from a manager to undertake work of a similar nature and level that is not specified above
- be courteous and provide a welcoming environment to all visitors to the school.
