## Information about the school

Gloucester Nursery School is a maintained nursery school. This means we are funded by the local authority and inspected under the same framework as primary and secondary schools. There are just under 400 maintained nursery schools in England and they are seen as beacons of best practice and specialists in early years education. We are very proud of our long history and our status as a maintained nursery school.

The head teacher works alongside the teacher, senior family worker and business manager as a senior leadership team. The head teacher also has the role of Senco. The rest of the staff team consists of nursery practitioners, nursery assistants, nursery workers and admin staff. The staff team are well qualified, have lots of experience and are fully committed to the school's ethos.

The school takes 2-4 year olds. We are open from 8.00 - 4.00, term time only. We currently have 25 two year olds and up to 62 three year olds. We have a very inclusive ethos and we have created specialist provision for children with complex special needs. We currently have 10 children who access this.

The school is located in an urban area in Northampton. The school consists of the original building and a newer building that is the base for our 2 year olds. The nursery has exceptional grounds, which includes a wildlife area with a large pond. Our grounds provide the children will access to challenging physical play, and so many opportunities to explore nature. We also have a sensory room, undercover area and dining room. The school is well maintained and well equipped. The school has a strong and well-established pedagogy based on child-led play supported by strong adult interactions. We have written sequential learning documents that outline the progression of learning across the school, and use these to plan alongside children's interests. We place great importance on developing independence skills, and feeder schools always comment on how ready for school our children are!

The role is full-time. The current head teacher is leaving at the end of April, so we ideally would like the role to start on May 1<sup>st</sup>. We would consider a later start date of September 1<sup>st</sup> for the right candidate.
