<ul style="list-style-type: none"> <li>• To work with the LGB, GLF Schools &amp; further key stakeholders to create a coherent vision for the school, ensuring it is clearly articulated, shared, understood and acted upon effectively by all.</li> <li>• Work within the school community to translate the vision, core aims, agreed objectives and operational plans which will promote and sustain continual school improvement.</li> <li>• Ensure that strategic planning recognises the emotional, intellectual, social and spiritual aspect of life and considers the diversities that comprise the makeup of the school and wider community.</li> <li>• Enhance opportunities through collaboration with other schools within the GLF family.</li> </ul>

<ul style="list-style-type: none"> <li>• To ensure a consistent and continuous school-wide focus on childrens' achievement, utilising data and appropriate benchmarks to monitor development in children.</li> <li>• Administer strategies that secure high standards of child conduct &amp; attendance.</li> <li>• Observe, evaluate and review classroom practice and promote improvement strategies.</li> <li>• Determines, organises and implements a diverse, flexible curriculum and puts into place an effective assessment framework.</li> <li>• Challenge under-performance at all levels, ensuring effective corrective action and follow-up through coaching and mentoring.</li> <li>• To ensure that learning is at the centre of strategic planning and resource management.</li> </ul>	

<ul style="list-style-type: none"> <li>● Demonstrate and articulate high expectations and set challenging targets all children.</li> <li>● Establishes teaching practices that will integrate the Foundation Stage, KS1 and KS2 into an effective Primary educational offering.</li> </ul>
<b>Securing Accountability</b>
<ul style="list-style-type: none"> <li>● The Headteacher is legally &amp; contractually accountable to the LGB &amp; GLF Schools for the school, its environment and all its work. The Headteacher also fulfils wider accountabilities in relation to children, parents, carers &amp; other relevant groups.</li> <li>● Utilises a range of evidence, including national, local and own schools performance data to support, monitor, evaluate and improve aspects of school life, including challenging poor performance and identifying educational trends.</li> <li>● Ensure individual staff accountabilities are clearly defined, understood and agreed, with the understanding that they are subject to rigorous review and evaluation.</li> <li>● Develop and present a coherent, understandable and accurate account of the schools performance to a range of audiences including LGB, GLF Schools, parents &amp; children.</li> <li>● Fulfils commitments arising from contractual accountability to the LA.</li> <li>● Ensure effective use of the schools budget and best practice in financial and employment matters.</li> </ul>
<b>Strengthening Community</b>
<ul style="list-style-type: none"> <li>● The Headteacher will engage with the internal and external school community and GLF Schools to secure equity and entitlement. This includes collaboration with other schools, with parents and carers and other agencies for the well-being of all children.</li> <li>● Work effectively with other educational institutions locally and further afield building effective partnerships.</li> <li>● Develop the provision of out of hours learning and extended learning opportunities.</li> <li>● Build and maintain effective relationships with parents, carers, partners and the community that enhance the education of children and the wider community.</li> <li>● Seek opportunities to invite parents, carers, community figures, businesses or other organisations into the school to enhance and enrich the school and its value to the wider community.</li> <li>● Recognising and championing opportunities for developing a rich and diverse school community, which respects the rights, responsibilities and dignity of all.</li> </ul>
<b>Managing the Organisation</b>
<ul style="list-style-type: none"> <li>● Ensure that within an autonomous culture, policies and practices takes account of national and local requirements, policies and initiatives and complies with legal requirements.</li> <li>● Recruit, retain, and deploy staff appropriately. Staff training and CPD should be first class and contribute to leading practice across the wider teaching school alliance.</li> <li>● Manage the schools financial and human resources effectively and efficiently to ensure the schools aims and goals are achievable.</li> <li>● Creates an organisation structure that reflects the schools values, and enables the management systems, structures and processes to work effectively in line with legal requirements.</li> <li>● Produces and implements clear, evidence-based improvement plans and policies for the development of the school and its facilities.</li> <li>● Ensure compliance with education statute and employment legislation.</li> </ul>

<ul style="list-style-type: none"> <li>• Ensure that the range, quality and use of all available resources is monitored, evaluated and reviewed to improve the quality of education for all children and provide value for money.</li> <li>• Manage the school environment efficiently and effectively, ensuring it meets the needs of the curriculum, health and safety regulations and safety of all children and staff.</li> <li>• Ensure a child support (pastoral care) system that focuses on each learner and supports school improvement.</li> </ul>
<b>Accountability</b>
<ul style="list-style-type: none"> <li>• The Headteacher is accountable to the Local Governing Body, CEO and GLF Schools for the standards achieved and the conduct, management and administration of the school subject to local and GLF policies.</li> <li>• GLF Schools expects its employees to work flexibly with the framework of the duties and responsibilities above. This means that the post holder may be expected to carry out work that is not specified in the job profile but which is within the remit of the duties and responsibilities.</li> </ul>
