



# Job Description



**JOB DESCRIPTION:** PRIMARY HEADTEACHER

**Leadership Scale:** Group 3 L11 - 24

**Responsible to:** Assisi Catholic Trust Board and the Local Governing Committee

As an employee of ACT, the Headteacher is required to carry out professional duties as detailed in this job description, and in Canon Law, the Trust Deed, Articles of Association and Memorandum of Understanding for academies.

## 1. Introduction

- 1.1 This appointment is with the Trustees and governors of the school under the terms of the Catholic Education Service contract signed with the governors/trustees as employers. The governors will appoint a practising Catholic who, by personal example and professional leadership, will ensure that the Catholic ethos, rooted in the teachings of Jesus Christ and the Catholic Church, permeates all aspects of life in the school.
- 1.2 The appointment is subject to the current conditions of service for headteachers contained in the School Teachers' Pay and Conditions Document and other current education and employment legislation.
- 1.3 This job description may be amended at any time, following consultation between the Headteacher, Trustees and the Governors and will be reviewed annually.

## 2 Core Purpose of the Headteacher

- 2.1 To set the context, the core purpose of the headteacher is to provide professional leadership and management for a school. This will promote a secure foundation from which to achieve high standards in all areas of the school's work. To gain this success, a headteacher must establish high quality education by effectively managing teaching and learning and using personalised learning to realise the potential of all pupils. Headteachers must establish a culture that promotes excellence, equality and high expectations of all pupils.
- 2.2 The core purpose of the Headteacher is to ensure that:
  - the school is conducted as a Catholic school in accordance with the teachings of the Catholic Church and Canon Law, and in accordance with the Trust Deed of the Diocese of Brentwood;
  - religious education is in accordance with the teachings, doctrines, discipline and general and particular norms of the Catholic Church;
  - religious worship is in accordance with the rites, practices, discipline and liturgical norms of the Catholic Church;
  - the school provides high quality teaching and learning that leads to successful outcomes for pupils in terms of spiritual and moral growth, achievement, attitudes to learning, behaviour and personal development;
  - the school will promote and safeguard the welfare of all children, enabling every child, whatever their background or their circumstances, to have the support they need to: be healthy; stay safe; enjoy and achieve; make a positive contribution; achieve economic well-being; recognise their own dignity and the dignity of others as children of God;
  - all statutory requirements are met and the work of the school is effectively monitored, evaluated and reviewed.

## General Duties and Responsibilities

To carry out the duties of the Headteacher as set out in the current School Teachers' Pay and Conditions Document.

The ethos and strategic direction should be established and sustained in partnership with the governing board and through consultation with the school community.</li><li>○ Ensure there is planned worship, and appropriate liturgy in accordance with the rites, practices, discipline and liturgical norms of the Catholic Church.</li><li>○ The vision must reflect its distinctive Catholic character, in accordance with the provisions of the Diocesan Trust Deed, based on what it means to be fully human as revealed in the person, life and teachings of Jesus Christ.</li><li>○ Create a culture where pupils experience a positive and enriching school life.</li><li>○ Uphold ambitious educational standards of excellence which prepare pupils from all backgrounds for their next phase of education and life.</li><li>○ To work with and motivate others to ensure creativity, innovation, and quality, including in the use of appropriate new technology, to achieve excellence and nurture human wholeness.</li><li>○ Promote positive and respectful relationships across the school community and a safe, orderly and inclusive environment.</li><li>○ Build a school culture and curriculum, based on Gospel values and the teachings of Jesus Christ and the Catholic Church, which takes account of the richness and diversity of the school's communities.</li><li>○ Build a relationship with the local church and parish communities, seeing participation in the celebration of the Eucharist as a crucial point of reference and stability.</li><li>○ Ensure a culture of high staff professionalism.</li></ul>
