JOB DESCRIPTION

JOB PURPOSE:

To contribute to the development of a strong, effective school with an emphasis on promoting a culture of educational excellence, within a caring and secure environment enriched with the values of discipline, mutual care and respect which extends beyond the school into the wider community.

JOB SUMMARY:

1. Assist in co-ordinating the provision on special educational needs learning and support.
2. Provide outstanding support to enable pupils with SEND to play a full and active part in the life of the school and to make outstanding progress in their learning.

KEY RESPONSIBILITIES AND ACCOUNTABILITIES

1 Support for Pupils

- 1.1 Provide support to named pupils with SEND as outlined in their Education, Health and Care Plans or Individual Education Plans.
- 1.2 Assess the needs of pupils and use detailed knowledge and specialist skills to support pupils' learning.
- 1.3 Liaise with teaching staff, Heads of Year and the SENCO regarding such support.
- 1.4 Work with teachers to secure outstanding progress in lessons for supported pupils.
- 1.5 Adapt or modify materials and resources to ensure full access to a broad and balanced curriculum.
- 1.6 Provide individual and/or small group intervention as directed.
- 1.7 Develop a positive relationship with pupils and promote self-esteem and independence.
- 1.8 Recognise the specific needs of individual children and understand how to respond effectively to periods of dysregulation.
- 1.9 Provide feedback to targeted pupils on their progress and attainment.
- 1.10 Contribute to the planning of opportunities for pupils to learn in out-of-school contexts in line with schools policies and procedures.

2 Support for Teachers

- 2.1 Provide information to teachers and other support staff on the most effective methods of provision and intervention for pupils with learning needs.

- 2.2 Liaise with the SENCO and specialist staff (e.g. Occupational Therapist or Speech and Language Service) as requested to receive and disseminate advice given to effectively support pupils across curriculum areas.
- 2.3 Liaise sensitively and effectively lead meetings with parents and carers, providing constructive feedback on student progress, attainment, attendance and behaviour.
- 2.4 Under the direction of the SENCO, contribute to student profiling of SEND by carrying out a range of specialist assessments.
- 2.5 Under the direction of the SENCO develop, monitor and review pupils' Individual Education Plans (IEPs).
- 2.6 Attend specific training as and when requested by the SENCO.
- 2.7 Assist in student supervision and management of student behaviour, in line with school procedures.
- 2.8 Be responsible for keeping and updating records as agreed with the teacher, contributing to the reviews of records and systems as requested.
- 2.9 Report on student achievement, progress and issues in a suitable format (i.e. verbally or in writing).
- 2.10 Assist teachers in offering mentoring support and guidance to other special support assistants undertaking formal training.
- 2.11 Where appropriate, to act as reader and/or amanuensis to pupils in examination and written assessments.

3 Support for the School

- 3.1 Support with the strategic management of SEND on days when the SENCO is not in school.
- 3.2 Manage other special support assistants and support their induction and professional development.
- 3.3 Develop curriculum resources to ensure that pupils identified on the SEN register have the required levels of support.
- 3.4 Within the context of the school's aims and policies, to work with the SENCO to develop and implement Learning support policies, plans, targets and practices.
- 3.5 Support and guide other special support assistants' work in the classroom when required.
- 3.6 Support the maintenance and enhancement of the school's ethos and mission through their own outstanding professional conduct and high expectations of others.
- 3.7 Be aware of and comply with policies relating to safeguarding (including child protection), health and safety, confidentiality and data protection.
- 3.8 Assist in creating a culture in which effective learning can take place.
- 3.9 Support the promotion of positive relationships with parents and outside agencies.
- 3.10 Ensure that accurate and detailed records are kept of meetings and discussions with parents and outside agencies.
- 3.11 Support the SENCO to ensure that the SEN Register is kept accurate and up to date and that staff are kept informed of student special educational needs.
- 3.12 Support meetings of SEN staff, communicate information to staff and co-ordinate resulting action.
- 3.13 Work within school policies and procedures.
- 3.14 Attend and participate in individual and team meetings as required.

- 3.15 Undertake personal development and improve own practice through training, observation, evaluation and discussion with colleagues including performance management and use this to support others.
- 3.16 Accompany teaching staff and pupils on visits, trips, out of school activities and enrichment programmes and take responsibility for a group under the supervision of a teacher, as required.
- 3.17 Work as part of a team and support the role of other people in the team.

4 Other Responsibilities

- 4.1 Promote the Trust's vision of 'nurturing today's young people, inspiring tomorrow's leaders'.
- 4.2 Champion the Trust's values of 'Service', 'Teamwork', 'Ambition' and 'Respect'.
- 4.3 Contribute to the wider life of the Trust and the Star community.
- 4.4 Carry out any such duties as may be reasonably required by the Trust.

5 Records Management

- 5.1 All staff who create, receive, and use records in the course of their job are responsible for ensuring that records are managed appropriately. It is therefore likely that this post-holder will have responsibility for record-keeping as part of the role. Employees are required to be conversant with the Trust's policies and procedures on records management.
