Ings Primary School is a community primary school located in the east of the City of Hull. The school has approximately 273 children on roll, including a 26 place purpose-built nursery within our Foundation Stage as well as a 10 place autism hub.

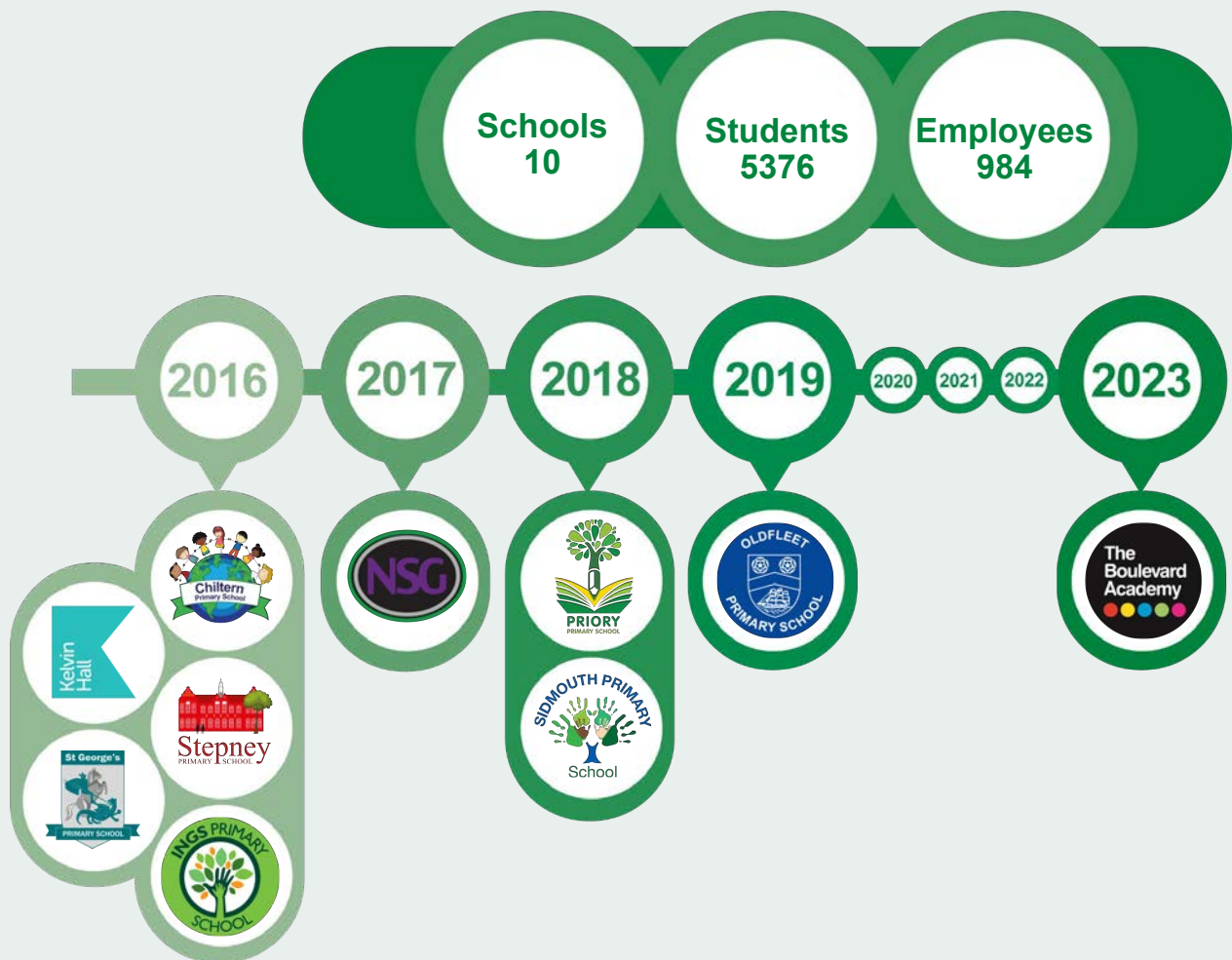
### Thrive Mission Statement *Inspiring pupils to thrive in life*

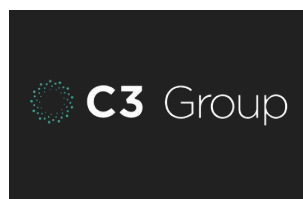

Ings Primary School is looking to appoint a Higher Level Teaching Assistant to join our team. The Orchard provision at Ings is an ASC hub for 10 pupils. This post presents an exciting opportunity for someone with experience of successful work with pupils with SEND to shape future development. The post-holder will lead the provision and a small team of TAs, supported by both the SLT and the Lead Teacher from our ASC Hub.

The purpose of the additional provision is to work with pupils:

- Away from mainstream classes over an extended time period.
- To deliver a curriculum that meets needs and develops cooperation.
- To support the development of skills and strategies to manage social, emotional and mental health issues such as anger and anxiety by the use of self-regulation strategies
- To integrate pupils to mainstream classes where possible as a blended learning approach

We are looking for a candidate who

- Understands the needs of pupils with SEND and how they best learn in an environment that supports their wellbeing.
- Can lead the Additional Provision successfully, bring creativity and initiative to this demanding role.

We also expect candidates to have excellent communication skills as well as excellent skills in English, Maths and other curriculum areas. The candidate will be hard working, creative, enthusiastic and able to work constructively and proactively as part of a team.

# Job Description

<b>Post Title</b>	HLTA- ASC Hub Lead
<b>Grade</b>	8
<b>Location</b>	Ings Primary School
<b>Reporting to</b>	Head of School and Senior Leadership Team

## Purpose of Role

To complement the professional work of teachers by taking responsibility for learning activities under the professional direction and supervision of a qualified teacher. This will involve planning, preparing and delivering learning activities for individuals/groups or short term for whole classes and monitoring pupils and assessing, recording and reporting on pupils achievement, progress and development. Responsible for the management and development of a specialist area within the school and/or management of other teaching assistants including allocation and monitoring of work, PDR and training.

## Key Responsibilities

1. To promote and safeguard the welfare of children and young people.
2. Assess the needs of pupils and use detailed knowledge and specialist skills to support pupils' learning
3. To lead The Hub successfully when the ASC Lead Teacher is engaged in linked tasks outside of The Hub, for PPA cover and training as well as other absences.
4. Establish productive working relationships with pupils, acting as a role model and setting high expectations
5. Develop and implement IEPs
6. Promote the inclusion and acceptance of all pupils within the classroom
7. Support pupils consistently whilst recognising and responding to their individual needs
8. Encourage pupils to interact and work cooperatively with others and engage all pupils in activities
9. Promote independence and employ strategies to recognise and reward achievement of self-reliance
10. Provide feedback to pupils in relation to progress and achievement
11. Organise and manage appropriate learning environment and resources
12. Within an agreed system of supervision, plan challenging teaching and learning objectives to evaluate and adjust lessons/work plans as appropriate
13. Monitor and evaluate pupil responses to learning activities through a range of assessment and monitoring strategies against pre-determined learning objectives
14. Provide objective and accurate feedback and reports as required on pupil achievement, progress and other matters, ensuring the availability of appropriate evidence
15. Record progress and achievement in lessons/activities systematically and providing evidence of range and level of progress and attainment
16. Work within an established discipline policy to anticipate and manage behaviour constructively, promoting self control and independence
17. Supporting the role of parents in pupils' learning and contribute to/lead meetings with parents to provide constructive feedback on pupil progress/achievement etc
18. Administer and assess/mark tests and invigilate exams/tests
19. Production of lesson plans, worksheet, plans etc.
20. Deliver learning activities to pupils within agreed system of supervision, adjusting activities according to pupil responses/needs
21. Deliver local and national learning strategies e.g. literacy, numeracy, KS1 & KS2, early years and make effective use of opportunities provided by other learning activities to support the development of pupils' skills
22. Use ICT effectively to support learning activities and develop pupils' competence and independence in its use



## Key Responsibilities

23. Select and prepare resources necessary to lead learning activities, taking account of pupils' interests and language and cultural backgrounds
24. Advise on appropriate deployment and use of specialist aid/resources/equipment
25. Comply with and assist with the development of policies and procedures relating to child protection, health, safety and security, confidentiality and data protection, reporting concerns to an appropriate person
26. Be aware of and support difference and ensure all pupils have equal access to opportunities to learn and develop
27. Contribute to the overall ethos/work/aims of the school
28. Establish constructive relationships and communicate with other agencies/professionals, in liaison with the teacher, to support achievement and progress of pupils
29. Take the initiative as appropriate to develop appropriate multi-agency approaches to supporting pupils
30. Recognise own strengths and areas of specialist expertise and use these to lead, advise and support others
31. Deliver out of school learning activities within guidelines established by the school
32. Contribute to the identification and execution of appropriate out of school learning activities which consolidate and extend work carried out in class
33. Manage other teaching assistants
34. Liaise between managers/teaching staff and teaching assistants
35. Hold regular team meetings with managed staff
36. Represent teaching assistants at teaching staff management/other appropriate meetings
37. Undertake recruitment/induction/appraisal/training/ mentoring for other teaching assistants
38. Any duties of a similar nature as directed by the class teacher or senior leadership team
