### HIGHER LEVEL TEACHING ASSISTANT - MFL

#### JOB DESCRIPTION

##### JOB PURPOSE:

To contribute to the development of a strong, effective school with an emphasis on promoting a culture of educational excellence, within a caring and secure Islamic environment enriched with the values of discipline, mutual care and respect which extends beyond the school into the wider community.

##### JOB SUMMARY:

1. Assist in co-ordinating the provision on special educational needs and MFL learning and support.
2. Provide outstanding support to enable students with SEND and other targeted pupils to play a full and active part in MFL and to make outstanding progress in their learning.

##### KEY RESPONSIBILITIES AND ACCOUNTABILITIES

#### 1 Support for Students

- 1.1 Provide support to named students with SEND and other targeted pupils in MFL.
- 1.2 Assess the needs of students and use detailed knowledge and specialist skills to support students' learning.
- 1.3 Liaise with MFL leaders, teaching staff, Heads of Year and the SENCO regarding such support.
- 1.4 Work with teachers to secure outstanding progress in lessons for supported students.
- 1.5 Adapt or modify materials and resources to ensure full access to a broad and balanced curriculum.
- 1.6 Provide individual and/or small group intervention as directed.
- 1.7 Develop a positive relationship with students and promote self-esteem and independence.
- 1.8 Provide feedback to targeted students on their progress and attainment.
- 1.9 Contribute to the planning of opportunities for students to learn in out-of-school contexts in line with schools policies and procedures.

#### 2 Support for Teachers

- 2.1 Provide information to teachers and other support staff on the most effective methods of provision and intervention for students with learning needs and other targeted pupils in MFL.
- 2.2 Liaise with the MFL leaders, SENCO and specialist staff (e.g. Occupational Therapist or Speech and Language Service) as requested to receive and disseminate advice given to effectively support students across MFL.

- 2.3 Liaise sensitively and effectively lead meetings with parents and carers, providing constructive feedback on student progress, attainment, attendance and behaviour.
- 2.4 Attend specific training as and when requested by the MFL leaders.
- 2.5 Assist in student supervision and management of student behaviour, in line with school procedures.
- 2.6 Be responsible for keeping and updating records as agreed with the teacher, contributing to the reviews of records and systems as requested.
- 2.7 Report on student achievement, progress and issues in a suitable format (i.e. verbally or in writing).
- 2.8 Assist teachers in offering mentoring support and guidance to other special support assistants undertaking formal training.
- 2.9 Where appropriate, to act as reader and/or amanuensis to students in examination and written assessments.

### **3 Support for the School**

- 3.1 Develop curriculum resources to ensure that students identified as at risk have the required levels of support.
- 3.2 Within the context of the school's aims and policies, to work with the MFL leaders and SENCO to develop and implement Learning support policies, plans, targets and practices.
- 3.3 Support and guide other teaching assistants' work in the classroom when required.
- 3.4 Support the maintenance and enhancement of the school's ethos and mission through their own outstanding professional conduct and high expectations of others.
- 3.5 Be aware of and comply with policies relating to safeguarding (including child protection), health and safety, confidentiality and data protection.
- 3.6 Assist in creating a culture in which effective learning can take place.
- 3.7 Support the promotion of positive relationships with parents and outside agencies.
- 3.8 Ensure that accurate and detailed records are kept of meetings and discussions with parents and outside agencies.
- 3.9 Work within school policies and procedures.
- 3.10 Attend and participate in individual and team meetings as required.
- 3.11 Undertake personal development and improve own practice through training, observation, evaluation and discussion with colleagues including performance management and use this to support others.
- 3.12 Accompany teaching staff and students on visits, trips, out of school activities and enrichment programmes and take responsibility for a group under the supervision of a teacher, as required.
- 3.13 Work as part of a team and support the role of other people in the team.

### **4 Other Responsibilities**

- 4.1 Promote the Trust's vision of 'nurturing today's young people, inspiring tomorrow's leaders'.
- 4.2 Champion the Trust's values of 'Service', 'Teamwork', 'Ambition' and 'Respect'.
- 4.3 Contribute to the wider life of the Trust and the Star community.
- 4.4 Carry out any such duties as may be reasonably required by the Trust.

## **5 Records Management**

- 5.1 All staff who create, receive, and use records in the course of their job are responsible for ensuring that records are managed appropriately. It is therefore likely that this post-holder will have responsibility for record-keeping as part of the role. Employees are required to be conversant with the Trust's policies and procedures on records management.
