- Communicate effectively and sensitively with parents and carers recognising their roles, rights and responsibilities in relation to pupils' learning
- Play an active role in full staff and key stage meetings and offer relevant expertise within a whole school approach to a particular development area
- Improve their own teaching, by evaluating it and learning from the effective practice of others and engaging in performance management
- Be motivated and able to take increasing responsibility for your own professional development
- Follow the school's confidentiality and safeguarding policy / guidelines
- Understand the need for confidentiality

Knowledge and Understanding

- Act as a lead for at least one subject area and implement, pinpointing areas for future development
- Know and understand the relevant National Curriculum programmes of study for your specialist subject
- Have good knowledge and understanding of all subjects and National Curriculum expectations taught across your key stage

- Establish an effective rapport with the children to help develop their social and academic potential
- Plan work appropriate to the pupils in the class in accordance with the school's schemes of work
- Set challenging teaching objectives which are relevant to all pupils
