## The Recruitment Process

All applicants are required to fully complete the Mercian Educational Trust application form which can be found on the [MET website](https://www.metacademies.org.uk). Completed applications should be emailed to our School Office at [GMPSOffice@metacademies.org.uk](mailto:GMPSOffice@metacademies.org.uk) or delivered to the school office. Applications in any other format will not be accepted.

Applicants must enclose details of two references. These must be recent; usually one will be a current employer who can comment on your suitability to work with children, however, if this is not possible, this can be a previous employer. We ask that friends and relatives are not named to provide a reference. We will ask for references from all short-listed candidates and require both references to be received before the interview. We may contact any previous employer listed on your form to clarify any information.

Shortlisting will be based on the applicant's suitability for the post linked to the job description and person specification. Please ensure your application matches these requirements. The closing date is Friday 13<sup>th</sup> February at 3:30pm. Applicants will be invited to interview via email following shortlisting, with the interview date planned for Wednesday 25<sup>th</sup> February 2026.

We are looking for a class teacher who is ideally able to start with us on the 13<sup>th</sup> April 2026. The position is initially for 1 term to cover the maternity absence but there is a possibility that the contract could be extended at the end of this period.

### **Job Purpose**

To have responsibility for teaching an assigned class and to be responsible for the day-to-day work and management of classes and the safety and welfare of the pupils as appropriate.

### **Supervisory details**

The post holder is responsible to the Headteacher for his/her teaching duties and responsibilities and teaching tasks. Where relevant the post holder is responsible for the supervision of the work of a teaching assistant.
