responsibilities specific to the post:	Develop, implement, monitor and maintain teaching policies and practices which reflect the school's commitment to high achievement and which are consistent with national and school strategies and policies.
	Monitor the progress made in achieving plans and targets, and evaluate the impact on teaching and learning.
	Disseminate good practice through INSET, coaching and mentoring mechanisms.
	Teaching and Learning: Set high expectations which inspire, motivate and challenge pupils. Have a full time teaching commitment that promotes good progress and outcomes by pupils.
	Demonstrate good subject and curriculum knowledge. Plan and deliver purposeful learning experiences.
	Adapt teaching to respond to the strengths, needs and interests of all pupils.
	Make accurate and productive use of assessment.
	Manage behaviour effectively to ensure a good and safe learning environment.
