Job Description

REENSHAW

The Lead of Computer Science role is an exciting addition to the Gloucester Academy Team.

The Department

This is an exciting opportunity to Lead a brand-new department in the school that ensures that our students are able to engage in computing at Key stage 3 and study Computer Science/interactive media at key stage 4. Gloucester Academy, as part of the Greenshaw Learning Trust is a collaborative one and the successful candidate will be working closely with other schools to share best practice.

We are introducing the subject into the school as we believe that students are entitled to discrete lessons to cover the computing curriculum computer science, digital literacy and Information Technology, Computing is a growing industry and we are very excited to be investing in.

The subject will fall within the Technology faculty and it is across this department where CPD and collaboration occur. This is supported by the working groups within the Greenshaw Learning Trust.

Curriculum

Our KS3 and KS4 curriculum is currently under construction to ensure that we meet and exceed the requirements of the national curriculum. The successful candidate will bring expertise with them and be supported by other teachers of computing across the trust. Possible course: Interactive Media is the integration of digital media including combinations of electronic text, graphics, moving images, and sound, into a structured digital computerised environment that allows people to interact with the data for appropriate purposes. This qualification focuses on an applied study of the Interactive Media sector and our students will gain a broad understanding and knowledge of working in this sector. The qualification begins with an introduction into Interactive Media and the factors that influence the choices made in the development process. The students are then expected to develop their ideas through exploration & amp; experimentation which will result in a final media product in response to a specific brief. Students then will carry out research into the Media industries and develop an understanding of potential careers within his sector.

All of our lessons are centrally created from a centralised model for T&L that embodies the Rosenshine principles and aspects of the Teach like a Champion approach. These are a starting point for you to be creative and own your curriculum. As part of a teaching team dedicated to improving the quality of our teaching, we regularly evaluate, adapt, improve or build upon pre-existing lessons to ensure they are of the best quality for our students so that every student can climb their own personal mountain to achieve success beyond Gloucester Academy.

Job Purpose

- To alert the appropriate staff to problems experienced by students
- To communicate as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff.
- To apply the Behaviour Policy so that effective learning can take place
- To meet with students over whom there are concerns and contact home where necessary in conjunction with year head or department head as appropriate
