This role is based at Co-op Academy Smithies Moor. A school that has made massive improvements in outcomes for our pupils at the end of KS2 and now needs to further embed the practice and standards in KS1 to ensure all our children have the best start in school. Working for Co-op Academy Trust in this role will also provide the opportunity for you to extend your influence beyond one school, by being an excellent teacher you will be able to act as a hub for practitioners from other schools to observe and seek advice from you.
