Purpose of Job:	To work in partnership with class teachers to support learning in line with the National Curriculum, Codes of Practice and school policies and procedures
Principal Accountabilities: Duties:	<ul> <li>Working with individuals or small groups of children under the direction of teaching staff.</li> <li>Implement planned learning activities/teaching programmes as agreed with the teacher, adjusting activities according to pupils' responses as appropriate</li> <li>Establish positive relationships with pupils</li> <li>Support pupils with activities which promote literacy and numeracy skills</li> <li>Support the use of ICT in the classroom and develop pupils' competence and independence in its use</li> <li>Promote positive pupil behaviour in line with school policies and help keep pupils on task</li> <li>Interact with, and support pupils, according to individual needs and skills</li> <li>Promote the inclusion and acceptance of children with special needs within the classroom ensuring access to lessons and their content through appropriate clarification, explanation and resources</li> <li>Participate in planning and evaluation of learning activities with the teacher, providing feedback to the teacher on pupil progress and behaviour</li> <li>Monitor and record pupil activities, as appropriate, writing records and reports as required.</li> <li>Provide feedback to pupils in relation to attainment and progress under the guidance of the teacher</li> <li>To support learning by arranging/providing resources for lessons/activities under the direction of the teacher</li> <li>To astist with the preparation, maintenance and control of stocks of materials and resources</li> <li>Assist with the development and implementation about pupils, as appropriate To assist with the display and presentation about pupils, as appropriate</li> <li>Laise with other staff and provide information about pupils, as appropriate</li> <li>To susport learling and presentation of pupils' work</li> <li>To suspire the information appropriate and control of stocks of materials and resources</li> </ul>

## Lunch Time:

- To maintain the safety, welfare and good conduct of the pupils during the midday break
- To assist children in selecting their meal and sitting in an appropriate place in the dining hall, or classroom for sandwiches
- To assist children with eating their meal, if applicable
- To clear tables when meals are finished and clear up any associated spillages
- To enforce the necessary sanctions for maintaining good order
- To administer basic first aid, as required
- To keep daily records of first aid administered, behaviour and sanctions employed, together with any other relevant records that may be needed
- To provide pastoral care, guidance and routine advice to pupils, as appropriate
- Where necessary and appropriate, to lead games and activities with the children
- To alert a senior member of staff with any concerns regarding an individual child or group of children

## General:

- To understand and apply school policies in relation to health, safety and welfare
- To attend relevant training and take responsibility for own development
- Attend relevant school meetings, as required
- To respect confidentiality at all times
- To participate in the performance and development review process, taking personal responsibility for identification of learning, development and training opportunities in discussion with line manager
- To comply with individual responsibilities, in accordance with the role, for health & safety in the workplace
- Ensure that all duties and services provided are in accordance with the School's Equal Opportunities Policy
- The Governing Body is committed to safeguarding and promoting the welfare of children and young people and expects all staff and volunteers to share in this commitment
