TASKS:

SUPPORT FOR THE PUPIL:

- Provide support to meet the needs of pupils within the Communication and Interaction ARP at Junction Farm Primary School. Working with individual pupils and small groups both within the ARP provision and supporting pupils to access mainstream classes where appropriate.
- Provide specialist support to pupils within the ARP ensuring the support requirements identified in their plans are met.
- Use specialist (curricular/learning) skills/training/experience to support pupils.
- Implement support plans for students with EHCPs, including attendance at, and contributing to review meetings.
- Establish productive working relationships with pupils
- Promote the inclusion and acceptance of all pupils within the school
- Support pupils consistently whilst recognising and responding to their individual needs.
- Encourage pupils to interact and work cooperatively with others and engage all pupils in activities.
- Promote good pupil behaviour, dealing promptly with conflict and incidents in line with the established policy and encourage pupils to take responsibility for their own behaviour.
- Provide feedback to pupils in relation to progress and achievement.

SUPPORT FOR THE TEACHER:

- Work closely with the SENDCo and other teaching staff to deliver tailored interventions and support strategies
- Foster a positive and inclusive learning environment, encouraging pupil engagement and confidence.
- Work with the teacher in lesson planning, evaluating and adjusting lessons/work plans as appropriate.
- Monitor and evaluate pupil's responses to learning activities through observation and planned recording of achievement against predetermined learning objectives.
- Provide objective and accurate feedback and reports as required, to the teacher on pupil achievement, progress and other matters, ensuring the availability of appropriate evidence.
- Be responsible for keeping and updating records as agreed with the teacher, contributing to reviews of systems/records as requested.
- Undertake marking of pupil's work and accurately record achievement/progress.
- Promote positive values, attitudes and good pupil behaviour, dealing promptly with conflict and incidents in line with established policy and encourage pupils to take responsibility for their own behaviour.
- Liaise sensitively and effectively with parents/carers as agreed with the teacher within your role/responsibility and participate in feedback sessions/meetings with parents, or as directed.
- Supervise and assess routine tests and invigilate examinations/tests.
- Provide general clerical/administrative support e.g. administer coursework, produce worksheets for agreed activities, etc.

SUPPORT FOR THE CURRICULUM:

- Implement agreed learning activities/teaching programmes, adjusting activities according to pupil responses/needs.
- Implement local and national learning strategies e.g. English, Maths, Early Years and make effective use of opportunities provided by other learning activities to support the development of relevant skills.
- Support the use of ICT in learning activities and develop pupil's competence and independence in its use.
- Help pupils to access learning activities through specialist support.

- Determine the need for, prepare and maintain general and specialist equipment and resources.

SUPPORT FOR THE SCHOOL:

- Be aware of and comply with policies and procedures relating to Child Protection, health, safety and security, confidentiality and data protection, reporting all concerns to an appropriate person.
- Be aware of and support difference and ensure all pupils have equal access to opportunities to learn and develop.
- Contribute to the overall ethos/work/aims of the school.
- Establish constructive relationships and communicate with other agencies/professionals, in liaison with the teacher, to support achievement and progress of pupils.
- Attend and participate in regular meetings.
- Recognise own strengths and areas of expertise and use these to advise and support others.

- Supervise pupils on out of school activities as required.
- Accompany teaching staff and pupils on visits and trips as required with appropriate responsibility.
- Participate in training and other learning activities and performance development as required.
