To support parents with after school provision, through ensuring their children are supervised and engaged in a range of activities.

The successful candidate will work within policies and procedures of Wroughton Academies, a member of Creative Education Trust.

- Undertake appropriate training and guidance including a food hygiene certificate.
- Plan and take responsibility for activities to support children between the hours stated.
- Ensure children have a nutritious snack during their time in the club.
- Be available and committed to supporting children in after school provision.
- Meet and greet parents.
- Registration of children on arrival.
- Ensure children transition smoothly from class to after school club provision, providing adequate supervision at all times.
- Work effectively with a wide range of pupils with a range of needs.
- Communicate well with stakeholders, including parents, children, and staff.
- Work under the direction and supervision of the after school club leader, seeking support where needed.
