#### Main purpose of the post:

#### **Care and Support:**

Provide the highest possible standard of care and emotional support to all children.

Assist with meeting children's basic physical and security needs and build positive relationships.

#### Inclusive Practice:

Ensure all children are valued and included, promoting an anti-discriminatory framework and meeting individual needs

#### Learning and Development:

Support the implementation of planned activities, contribute to children's learning, and record their achievements

Engage in play experiences and interactions with children, valuing their choices and interests. Be familiar with and work within the EYFS principles, curriculum and welfare requirements.

#### Observation and Assessment:

Ensure accurate observations, assessments, and other records are maintained and are accessible to parents/carers.

Use observation and assessment to support curriculum planning.

#### Partnership with Parents:



Interact with parents/carers, providing information and feedback about their child's day. Liaise with parents/carers to ensure effective communication and parent partnership.

Support the Day Nursery Manager building links and working in partnership with parents, carers, and professionals.

#### •Teamwork:

Work as part of a team, contributing ideas for developing the setting

Work alongside colleagues in a productive and positive way and attend staff meetings. Contribute to a positive, enthusiastic, and progressive team.

#### •Environment and Resources:

Assist with the smooth running of the setting and with tasks which ensure the daily routine can be implemented, taking account of children's individual needs

Support the provision of an environment which is clean, safe and attractive and take appropriate steps to remedy or report issues in relation to this

Ensure the care of nursery rooms and equipment

Maintain supplies of materials and equipment
