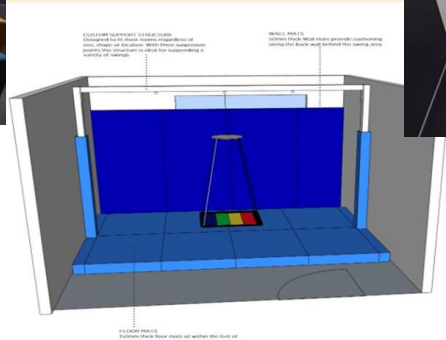

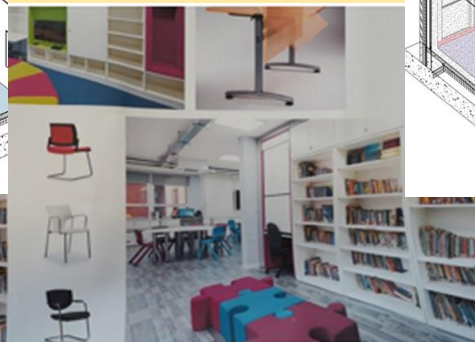

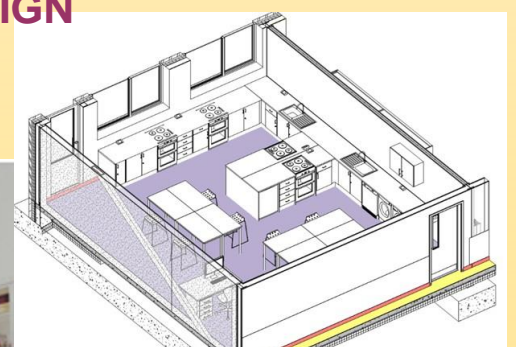

In September 2019, MacIntyre Academies Trust opened a new and exciting Academy in a purpose-built state of the art building in Rugby, Warwickshire for children and young people with social, emotional and mental health needs and/or autism, aged between 7 years and 19 years. The school has specialist facilities including a sensory room, therapy room, interactive immersive classroom, soft play room, recording studio and photography suite. We are very proud of our holistic curriculum which enables the pupils to benefit from blended therapy in the classroom. We have a café located at the front of the school where parents can meet and the pupils can display the items they have made within the school which will be available to purchase. We are passionate to support our pupils and families from the local community to ensure the best outcomes.

Whilst the new building was being constructed the academy was located in a temporary modern school building on the outskirts of Nuneaton and opened with 30 pupils in September 2017 rising to 55 pupils in September 2018.

Job Purpose:	<p>The Position of Occupational Therapist to be one of considerable responsibility and confidentiality. The post holder will be expected to show judgement and initiative at a level which is commensurate with this expectation of MacIntyre Academies Trust.</p> <p>The successful candidate will require an up-to-date knowledge and experience of legislation and policies relevant to social care and health.</p> <p>The main purpose of this role is to use OT skills to support and maintain safe practice and services for Quest Academy learners and to develop and deliver training to maintain high standards of practice using innovation in your practice. The successful candidate will need to have knowledge of a range of services including assistive technology, the digital switchover, equipment, appropriate compensatory techniques and moving and handling experience to support or represent the service as required in different professional forums.</p> <p>The candidate needs to be adaptable to new ways of working and have a keen interest in improving services. The successful candidate will be required to be flexible to meet the needs of the service.</p> <p>The role requires autonomy and excellent organisational skills and also requires the ability to work flexibly according to the needs of the service, which can be both dynamic and fast paced.</p>



Key Responsibilities:

1. To assess and evaluate the young person's functional performance and impairments
2. To deliver individual and group OT sessions.
3. To assess and evaluate the young person's functional performance and impairments.
4. To develop and provide a specialised paediatric occupational therapy service undertaking assessment, interpretation of assessment results, evaluation, diagnosis, treatment, advice and review.
5. To work alongside other specialist and support staff to support pupils in class so that they can assess their lessons.
6. To develop, plan and implement specialist OT treatment programmes and strategies to enhance the young person's ability to perform everyday activities and participate in multiple environments.
7. To establish realistic goals and meaningful outcomes with the young person, parent/carer and classroom staff.
8. To ensure that young people and their parents/carers are involved in the planning and prioritisation of their care plans wherever possible.
9. To monitor and review the progress of the young person against set targets and to modify targets as appropriate.
10. To monitor, evaluate and modify treatment(s) in order to measure progress and ensure effectiveness of intervention.
11. To evaluate outcomes of specialist interventions.
12. To ensure that children and young people within the school are referred to other services as appropriate.
13. To assess the young person's need for small aids and specialist equipment, advise and recommend appropriate items for use at home and school.
14. To check size and suitability of equipment as required including the adjustment of equipment to suit the young person's changing needs in a range of performance contexts
15. To work closely with young people and their parents/carers agreeing decision making relevant to individual care management.
16. To demonstrate appropriate physical management of young people with disabilities.
17. To appropriately manage programmes for young people who have challenging behaviour
18. To attend relevant multidisciplinary meetings where relevant.
19. To produce high quality, functional reports for annual review meetings etc.
20. To undertake any other duties as required by your line manager.
