FIXED TERM PART TIME TEACHER

Thank you for your interest in this post which is offered from January 2023, ideally from the start of term (or as soon as possible after this). I enclose a job profile and person specification, along with an application form. Please complete the application and return it to us by **9am** on **Tuesday 6th December**. Please make clear on your application your experience as a KS2 teacher, in particular in relation to maths teaching, as well as any curriculum interests/strengths. We anticipate interviewing short-listed candidates on **Thursday 15th December** with the interview panel comprising Jo Laker (Executive Headteacher), Kate Davis (Head of School) and at least one member of the Local Governing Body. As part of the interview, short-listed candidates will be asked to teach a lesson to either Y3/4 or Y5/6 pupils and complete a planning task.

The school is committed to safeguarding and promoting the welfare of children in its care and expects all staff to share this commitment. The school recognises that an important element in keeping children safe from harm is to ensure that unsuitable people do not have access to the school. Applicants will be required to undertake pre-employment checks which will include excellent references (to include an assessment of the candidate's suitability to work in a school), health, right to work in the UK and Disclosure and Barring Service. The successful candidate will be expected to follow and contribute to the school's policy for Child Protection (available from the school and on the school website). All disabled applicants who meet the essential criteria in the person specification will be interviewed. All applicants will be considered on the basis of suitability regardless of sex, race, gender, religion or belief, marital status or disability.

The successful candidate should have recent relevant experience of teaching and assessment in KS2, including reading and maths, fostering relationships with families and working with teaching assistants. The teaching commitment is part time 0.4 (with 0.04 paid as PPA time), teaching a KS2, mixed age reading group and a Y3/4 maths class and Y5/6 maths class on a Monday – Thursday morning. For the right candidate, there is the opportunity to lead maths across the school with the support of the Head of School.

The school is an academy as part of the 'Good Shepherd Multi Academy Trust'. The successful candidate's employment would be with the Good Shepherd Multi Academy Trust although the terms and conditions would be comparable to Cumbria County Council.
