

## **Job Description for the Post of Primary Psychotherapist at Nightingale Community Academy**

### **Job Purpose:**

As a Primary Psychotherapist, you will work as part of a committed, multidisciplinary team to support the emotional development, mental wellbeing and therapeutic needs of pupils with SEMH. You will provide a safe, consistent, and nurturing therapeutic provision that supports pupils to develop emotional regulation, resilience and positive engagement with learning and relationships.

### **Key Responsibilities:**

#### **1. Therapeutic Support and Intervention**

- Provide individual psychotherapy sessions for primary-aged pupils in line with identified needs.
- Deliver therapeutic interventions using an integrative counselling and psychotherapy approach.
- Use play-based therapeutic techniques to support communication and emotional expression.
- Support pupils to develop emotional regulation skills, coping strategies and self-awareness.
- Maintain a therapeutic environment that promotes safety, trust, and emotional containment.

#### **2. Assessment, Planning and Review**

- Complete therapeutic assessments and contribute to appropriate therapy plans and targets.
- Maintain clear therapeutic goals and review progress regularly with pupils and relevant staff.
- Adapt interventions responsively based on pupil progress, needs and engagement.
- Provide written summaries and reports where appropriate to inform school planning and pupil support.

#### **3. Supporting SEMH Needs and Wellbeing**

- Build strong, trusting relationships with pupils who may have experienced trauma, disrupted attachments or adversity.
- Promote emotional literacy and help pupils identify feelings and behavioural triggers.
- Contribute to a trauma-informed approach that supports regulation and relational repair.
- Work collaboratively to reduce barriers to learning and improve wellbeing outcomes.

#### **4. Working Collaboratively**

- Work closely with the Therapist Coordinator, pastoral staff, teachers and senior leaders to provide joined-up support.
- Contribute to multi-disciplinary meetings, including safeguarding and behaviour support discussions.
- Liaise with parents/carers when appropriate, ensuring communication remains professional and child centered.
- Work with external professionals and agencies as needed to support pupil outcomes.

#### **5. Safeguarding and Professional Practice**

- Always promote and safeguard the welfare of children and young people.
- Be aware of and follow all school safeguarding and child protection procedures.
- Maintain professional boundaries, confidentiality and ethical practice in line with BACP/UKCP standards.
- Escalate concerns appropriately and contribute to ongoing risk management and safety planning where required.

## **6. Supervision, CPD and Record Keeping**

- Engage in external clinical supervision and reflective practice to support safe and effective work.
- Attend internal supervision and line management meetings with the Therapist Coordinator.
- Maintain accurate records of sessions, outcomes and progress in line with school systems and expectations.
- Commit to continued professional development relevant to SEMH, primary mental health and therapeutic practice.

- The responsibilities listed above are the essentials of the post; it is always open to the postholder to propose ways of extending these responsibilities
