<p><u>Overall Purpose of Job:</u></p> <p>As a Primary Teacher you will teach pupils across the full age and ability of Key Stage 1 & 2 in order to ensure the highest possible standards of pupil achievement, personal development, and well-being.</p>

You will teach allocated pupils by planning teaching which achieves progression of learning through: <ol style="list-style-type: none"> i. identifying clear teaching objectives and specifying how they will be taught and assessed ii. setting tasks which challenge pupils and ensure high levels of interest iii. setting appropriate and demanding expectations iv. setting clear targets, building on prior attainment v. identifying SEN or very able pupils vi. providing clear structures for lessons maintaining pace, motivation, and challenge vii. making effective use of assessment and ensure coverage of programmes of study viii. ensuring effective teaching and best use of available time ix. monitoring and intervene to ensure sound learning and discipline x. using a variety of teaching methods to: <ol style="list-style-type: none"> a. Match approach to content, structure information, present a set of key ideas and use appropriate vocabulary b. 8. You will assess and record pupils' progress systematically and keep records to check work is understood and completed, monitor strengths and weaknesses, inform planning and recognise the level at which the pupil is achieving.
